Chinua Achebe ("The art of fiction") famously observed that until lions have their own historians "the history of the hunt will always glorify the hunter." In this volume chronicling the complex imperial and colonial entanglements of the Kpando region in eastern Ghana over recent centuries, the lions have found their proverbial historian. Drawing on an array of sources—archaeological, oral historical and documentary—Wazi Apoh brings locally nuanced perspective to the complex social political economic entanglements among Akpini, German and British actors. His illumination of previously silenced histories provides a rich platform from which to provoke us to imagine and act on the possibilities for restorative repatriation in the present. Its novel combination of historical study with analysis of ongoing dialogues over repatriation is a unique contribution to African studies.

Notable highlights include his role in Kenya's Shifta Campaign of the 1960s and engaging with rebels during peace operations he led in Namibia, Mozambique, Liberia, and Sierra Leone. In retirement, General Opande has occasionally mediated conflicts; among them the 2007, 2008, 2013 and 2017 election crises in Kenya and the aftermath of the 2015 upheavals in South Sudan. Nhakanomics: Harvesting Knowledge and Value for Re-generation through Social Innovation is a radical departure from the commonly held belief that neo-liberal economics from the US and the West is universal, and is the only solution to underdevelopment and poverty throughout the world. Instead, the book teases out and theorises the intellectually rutted terrain of development studies, and neo-liberal economics from a decolonial Pan-Africanist perspective. Following a path of social innovation, with perspectives drawn from social anthropology, economics, and business and management studies Nhakanomics is a unique socio-economic approach applicable in the Global South and in Southern Africa in particular. The study argues that the process and substance of nhakanomics with its pre-emphasis on the relational South provides a robust and holistic approach to social innovation and social transformation grounded in relational networks and 'meshworks'. The central idea is a call to re-GENE-rate society, through local Grounding and Origination, and tapping into local-global Emergent Foundations via a newly global Emancipatory Navigation, while ultimately culminating in global-local transformative Effects in four recursive cycles of re-GENE-rating C(K)umusha, Culture, Communication, and Capital after re-Constituting Africa-the 5Cs. With a novel and radical approach the book is an interrogation of neo-liberal economics in the Global South. As such, this book is remarkably handy to students and practitioners in the fields of economics, development studies, political science, science and technology studies, business management, sociology, transformation studies, and development related non-Governmental Organisations working with grassroots communities.

Boxing is no cakewalk! Azumah 'Ring Professor' Nelson in the Social History of Ghanaian Boxing explores the social history of boxing in Ghana and its interesting nexus with the biography of Azumah Nelson, unquestionably Ghana's most celebrated boxer. The book posits that sports constitute more than mere games that people play. They are endowed with enormous political, cultural, economic and social power that can influence people's lives in various ways.

Boxing is no cakewalk! interrogates the social meaning and impact of boxing within the colonial and postcolonial milieux of popular culture in Ghana. Consequently, it reconsiders the prevailing conception of boxing as adversative to 'enlightened' human culture by arguing that it is a positive formulator of individual and national identities. The historicising of sports and the lives of sportspersons in Ghana provides an eloquent backdrop for an understanding of the past social dynamics and their effect in the present.

Using one of the continent's supposed pathfinders, Cameroon as case-study, this book interrogates judiciary in Africa in three domains. First, as the third branch of government, second, as the acknowledged umpire of federalism, and, finally, as a means of reversing the institutionalization of in-human rights and injustice administration in Africa. While examining the roots and causes of the persisting human rights and justice administration problems in Cameroon particularly, and Africa in general, the book through the tumbu-tumbu Long-Distance Government Theory (LDGT), argues for a rethinking and freeing of strategies currently used from close to a century of colonial and neo-colonial bondage, under the confusing covers of 'independence' and of 'advanced democracy'. The book challenges Africa to consider a mentality change, for a 'real' judiciary transformative change. The book will interest legal practitioners, social anthropologists, development studies and political science practitioners, among other such practitioners in the social sciences and humanities.

The collection fulfills a gap in the quest for a documented piece of work on the general pattern and structure of Nigerian names and is an invaluable material for comparative purposes.

There are 19 papers in section A focusing mainly on various aspects of sociolinguistics and the role of language in society. Section B comprises 24 papers which fall in the area of stylistics, literature and gender studies. Section C contains 21 papers focusing on applied areas of linguistics. Section D comprises 11 papers on information science and communication studies. Section E contains papers that focus on the formal areas of linguistics, i.e. phonetics, phonology, morphology, syntax & semantics. Section F is on Okon Essien as a celebrity. It comprises papers which not only x-ray the contributions of the celebrity to the study of languages and linguistics in Nigeria, but also situate him in the context of other linguistic celebrities globally. Section F is wrapped up with a collection of brilliant poems dedicated to Professor Okon Essien by the 'Ode Grandmaster', Dr. Obed Ojukwu. Politics as Dashed Hopes in Nigeria details the experiences of the author, who ran a gubernatorial campaign for the Congress for Progressive Change in Kano State, in 2011, with the politics within the Congress for Progressive Change (CPC), leading to the 2011 elections in Nigeria, particularly in Kano State and Nigeria's presidency. The book reveals the inner workings of the CPC and the intriguing drama that unfolded within its inner caucus discusses the tactical blunders and errors of judgement which were responsible for the party's unimpressive performance in the 2011 polls in Kano State in particular and the nation at large. These accounts are also the story of the then leader of the CPC, General Muhammadu Buhari, whose image loomed large in the activities of the party; the idea of the existence of a cult-figure in Nigerian politics, versus the concept of due process in political party administration, is, therefore, an issue of paramount interest to the book.

Islam and Modernity: An Unfinished Project / Rafik Abdessalem Johannesburg: Afro-Middle East Centre, 2017 x, 356p. ; 229 x152mm. Includes Index ; Bibliography 9780994704818 \$ 40.00 / PB 546gm.

In this compelling book, Rafik Abdessalem unpacks two major lines of thought. Firstly, he examines why many Westerners dismiss Islam's vast intellectual, social, theological and cultural heritage as flawed, violent, rigid and fanatical, despite knowing virtually nothing about it. He usefully traces the genesis of this attitude, focusing on how scholars such as Weber, Habermas and others have helped to consolidate the West's view of itself as civilised, superior, developed and progressive, and how the demonisation of Islam acts as a necessary foil for these notions. Secondly, he explains that Islam is subject to a variety of interpretive choices and schools of thought ranging from legalistic fundamentalism, through rigid rationalism, to spiritual Sufism. By treating Islam, secularity and modernity as distinct and separate, rather than as interconnected and overlapping, Abdessalem makes no attempt to reconcile Islam with modernity or secularity, nor does he place one in opposition to the other. Instead, he looks at the interconnections between these broad and complex subjects. Abdessalem's analysis is useful in encouraging us to rethink both modernity and Islam, and their relationship with each other. News footage of disease in Africa is a familiar sight. Yet these outbreaks are often presented out of context, with no reference to the conditions that have triggered them. MISTRA's new book, Epidemics and the Health of African Nations, aims to redress that. Researchers and practitioners from within the continent explore why Africa is so vulnerable to disease, and show how this vulnerability is closely linked to political and economic factors. They demonstrate how these same factors determine the way epidemics are treated.

Authors extract lessons from case studies in different parts of Africa; challenge conventional frameworks about disease to argue for a 'syndemics' approach that takes into account the interrelationship between disease and political and socio-economic contexts; explore challenges of Africa's future. They argue that a well-functioning health system is at the core of a country's capacity to counter an epidemic.

This volume brings African experts together to probe possible solutions to the continent's heavy burden of disease. The insights offered will be helpful in devising policy for the control of disease and the combatting of epidemics in Africa.
