The biography of one of New Zealand's greatest naturalist-artists, G. V. Hudson. George Hudson, 1867-1946, was one of New Zealand's pioneer naturalists, who devoted his life to collecting and describing the New Zealand insect fauna. He amassed what is probably the largest collection of New Zealand insects, now housed at Te Papa. Hudson also wrote seven books on insect fauna between 1898 and 1946, each illustrated in colour with immaculate paintings of the specimens, a total of over 3100 paintings, mainly focused on moths and butterflies. An Exquisite Legacy is a biography of Hudson, written by his grandson Dr George Gibbs, himself a prominent entomologist. Gibbs outlines the life of this naturalist and artist, whose dedication and output was truly remarkable. Hudson remained an amateur naturalist

his whole life, but his contribution to our knowledge about the New Zealand insect world is of enduring significance, while his artistic legacy, built up over nearly seven decades, is truly remarkable. This extensive collection of exquisite illustrations is without parallel in New Zealand. Beautifully illustrated throughout, this biography of George Hudson is the first chance for most people to see his exquisite artwork. Up until now, his books have been valuable collectors' items unavailable to most people. A foreword by Courtney Johnston, Chief Executive of Te Papa Tongarewa, provided in recognition of the importance of this book, and the significance of the Hudson Collection at Te Papa.

Oscar's love of flying saw him joy riding to many places in the world, including New Zealand, South Africa, and up through Africa to Palestine. While based in London, he joined British Airways and Imperial Airways flying flying boats across the Empire. Finally, he came to rest in Auckland, New Zealand, after delivering the Awarua, the second of New Zealand's flying boats, used during World

War II for communication and travel, reducing New Zealand's isolation. He became Chief Pilot of TEAL, the New Zealand airline, for half of the war years and beyond, and eventually resigned due to serious disagreement over management and political agendas. There has never been a man equal to Te Rauparaha in terms of knowledge of warfare and prowess in battle, and in being so dedicated to looking after people. - Tamihana Te Rauparaha Te Rauparaha is most well known today as the composer of the haka 'Ka Mate', made famous the world over by the All Blacks. A major figure in nineteenth-century history, Te Rauparaha was responsible for rearranging the tribal landscape of a large part of the country after leading his tribe Ngati Toa to migrate to Kapiti

Island. He is venerated by his own descendants but reviled with equal passion by the descendants of those tribes who were on the receiving end of his military campaigns in the musket-war era. He Pukapuka Tatau i nga Mahi a Te Rauparaha Nui is a 50,000-word account in te reo Maori of Te Rauparaha's life, written by his son Tamihana Te Rauparaha between 1866 and 1868. A pioneering work of Maori (and, indeed, indigenous) biography, Tamihana's narrative weaves together the oral accounts of his father and other kaumatua to produce an extraordinary account of Te Rauparaha and his rapidly changing world. Edited and translated by Ross Calman, a descendant of Te Rauparaha, He Pukapuka Tatau i nga Mahi a Te Rauparaha Nui makes available for the first time this major work of Maori literature in a parallel Maori/English edition.

This ground-breaking book explores the birth, growth, struggles and ongoing life of Te Hahi Mihinare - the Maori Anglican Church. Anglicanism arrived in New Zealand with the first English missionaries in 1814 but was made widely known by Maori evangelists. The new religion profoundly influenced some iwi, who in turn adapted and made it their own. The ways in which Mihinare (Maori Anglicans) engaged with the settler Anglican Church in New Zealand and created their own unique church casts light on the broader question of how Maori interacted on their own terms

with European culture and institutions. A cast of memorable characters, including nationally wellknown figures such as Apirana Ngata and internationally significant figures, such as Bishop Azariah from India, vividly people the pages of this fascinating book. Author Hirini Kaa describes the quest for a Maori Anglican bishop, the translation into te reo of the prayer book, and the development of a distinctive Maori Anglican ministry. In the process, Kaa uncovers a rich history that enhances our understanding of New Zealand's past.

The Ngai Tahu settlement, like all other Treaty of Waitangi settlements in Aotearoa New Zealand, was more a product of political compromise and expediency than measured justice. The Ngai Tahu claim, Te Kereme, spanned two centuries, from the first letter of protest to the Crown in 1849 to the final hearing by the Waitangi Tribunal between 1987 and 1989, and then the settlement in 1998. Generation after generation carried on the fight with hard work and persistence and yet, for nearly all Ngai Tahu, the result could not be called fair. The intense negotiations between the two parties, Ngai Tahu and the Crown, were led by a pair of intelligent, hard-nosed rangatira, who had a constructive but often acrimonious relationship - Tipene O'Regan and the Minister of Treaty Negotiations Doug Graham - but things were never that simple. The Ngai Tahu

team had to answer to the communities back home and iwi members around the country. Most were strongly supportive, but others attacked them at hui, on the marae and in the media, courts and Parliament. Graham and his officials, too, had to answer to their political masters. And the general public - interested Pakeha, conservationists, farmers and others - had their own opinions. In this measured, comprehensive and readable account, Martin Fisher shows how, amid such strong internal and external pressures, the two sides somehow managed to negotiate one of the country's longest legal documents. 'A Long Time Coming' tells the extraordinary, complex and compelling story of Ngai Tahu's treaty settlement negotiations with the Crown. But it also shines a light, for both Maori and Pakeha, on a crucial part of this country's history that has not, until now, been widely enough known.
