This book contains principal guidelines and providing historical information and skills for effective interpretation. It aims to improve heritage interpretation skills of tour guides and history enthusiasts in Ternate, North Maluku. The content of the book including principles of interpretation, interpretive planning and the use of themes, making tours meaningful and interactive, and evaluating tour success. Taking Fort Oranje and its colonial history as the focus of the discussion, it was stressed that the significance of the tangible heritage (the fort) could not be separated from the intangible heritage links to the local community and world events. Making the heritage meaningful to local and international audiences was seen as a contribution to heritage protection and fostering understanding of how the Spice Islands were the center of global trade for more than three centuries.

This is the Final Report of the Judges who participated in the hearings held in the Nieuwe Kerk, The Hague, Netherlands from 10 to 13 November 2015. Before the hearings, the judges received the Indictment and Prosecution Brief, as well as extensive background documentary material in the form of a Research Report of over six hundred pages. During the four days of hearings, the judges heard the oral submissions of the prosecutors, as well as the testimony and responses to questions of more than 20 witnesses (some of whom testified with their identities protected under pseudonyms and/or behind screens). The judges also received several hundred pages of documents, tendered as evidence. The prosecution presented its case as nine counts, alleging the commission of the following crimes against humanity: (1) Murder, (2) Enslavement, (3) Imprisonment, (4) Torture, (5) Sexual Violence, (6) Persecution, (7) Enforced Disappearance, (8) Hate Propaganda and (9) Complicity of Other States.

Following the hearings, the judges examined the evidence and supporting material further, in their preparation of this Report. Helen Jarvis and John Gittings prepared and edited the Report, assisted by Shadi Sadr, Mireille Fanon-Mendes France and Zak Yacoob. Judge Yacoob provided a legal overview of the text. The Report amplifies and provides reasoned justification for the Judges' Concluding Statement, delivered during the final session of the hearings on 13 November 2015 (see A3 below). It begins by addressing the overarching question of responsibility for the mass murders and other crimes; it then focuses on the counts presented by the Prosecution and in an *amicus curiae* Brief submitted to the Tribunal; and concludes with a series of findings and recommendations.

It is regrettable that the State of Indonesia did not accept the invitation to participate in the hearings or make submissions to the Tribunal. The governments of the United States, the United Kingdom and Australia, also did not accept the invitation extended by the Tribunal. The judges welcomed the willingness of individual members of Indonesian National Human Rights Commission, Komnas HAM, and the National Commission on Violence Against Women, Komnas Perempuan, to brief the Tribunal.

The term "imitation" or "mimesis" has been widely used. All creatures, including humans, use mimesis as a means of survival. Mimetic is widely regarded as a result of imitation in all forms of cultural transmission (language, tradition, and values). It indicates that mimeticity pervades all aspects of human life, yet it is rarely investigated thoroughly. Nevertheless, imitation has been developed in literary works to the point that each line, when interpreted

in terms of play texts, has a profound, complete, and sometimes even negative significance. Humans are always in need of something to keep them alive. They imitate nature or another person to obtain what they want. As a result, in theory, mimesis desire is the primary motivation of people and hence a phenomenon prevalent in all facets of society. All terms linked to mimesis are typically associated with imitation. Some people may not desire impulsively but rather imitate the desire of others. The desire does not originate in itself or in the item, but in a third person. In other words, between a desire and its target, there is always some amount of social mediation. Being imitative or mimetic might thus be defined as mediated want: a desire that is never totally someone's own. That is, imitators do not have the same desire as models. Nevertheless, due to the mimetic process (mimetize), this desire creates a medium for having the same desire as a model's desire.
