Retrospects and Prospects of the Rice Economy of Bangladesh

In Retrospects and Prospects of the Rice Economy of Bangladesh, Dr. Raisuddin Ahmed analyses and describes the progress in rice production during the last 20 years and the prospect of the rice economy in the first decade of the 21st century. The book demonstrates that the achievements have been significant but uneven, with a robust progress in the northwestern districts and a near-stagnation situation

in northeast, central low lying, and coastal districts of Bangladesh. A gain in productivity, based on seed-fertilizer-irrigation technology has been the single largest source of growth in the past. Sustaining the overall progress attained so far and breaking the stagnation in the laggard districts will call for some drastic adjustments in the institutional mechanisms pertaining to irrigation and water control management and redirection in seed-fertilizer technology. Mechanical technology in cultivation is also poised to make a major difference in the future. Looking forward, the book suggests that rice will continue to play a dominant role in the agricultural economy of Bangladesh in the near future, though in the long run, increased diversification of agriculture into high-value products is expected. A declining pace of population growth and smaller income effects on the demand side, and continuation of technological diffusion on the supply side, may give Bangladesh an exportable surplus of rice by the year 2010. The challenge is for appropriate policy and institutional change to exploit the technological potential for increased productivity in the rice sector.

This book analyses trends and impact of trade liberalization in Bangladesh. Bangladesh's trade liberalization effort started in the mid-1980s as an important component of the structural adjustment programme sponsored by the Bretton Woods Institutions - the World Bank and the International Monetary Fund. Compared to the highly restrictive and inward-oriented nature of the trade regime that prevailed before the mid-1980s, Bangladesh presently has a less restrictive and more outward-oriented trade policy environment. This is a result of the commendable progress made in eliminating a sizable portion of import tariff and non-tariff barriers and adopting a flexible exchange rate policy. The present work is a comprehensive attempt to examine the impact of trade liberalization on the volume of import demand, export supply, industrial growth, and government revenue in Bangladesh using the modern time-series methods of co-integration and error correction modelling.

The volume contains a selection of papers generated in the course of a Link Programme on industrialisation between the Bangladesh Institute of Development Studies (BIDS) and the University of Strathclyde in Glasgow. In focusing broadly on the strategy of industrialisation, relevant theoretical and empirical issues are brought forward dealing in particular with external competitiveness and economic development.
