The rural financial market of Bangladesh is now largely dominated by microfinance institutions and has changed dramatically in the last three decades. In 1983, the Bangladesh government provided regulatory support to Grameen Bank, the first microfinance bank in the country. With the formation of the Microcredit Regulatory Authority or MRA, it responded to another regulatory need for NGO microfinance activities (NGO-MFIs) in 2006, twenty-three years after its first response to Grameen. These two sets of regulations, their followup amendments, and other supplementary rules have had an immense impact in institutionalising microfinance in Bangladesh. This book attempts to understand the regulatory role of the government, its background and purpose, evolving characteristics, implementation procedures, and the role of state agencies like Bangladesh Bank, the central bank of Bangladesh and the new regulatory authority for NGO-MFIs, the MRA. In doing so, this book takes an institutional approach, and uses a basic IAD (Institutional Analysis and Development) framework to analyse historical data. The data gathered is in the form of documents, interviews, focus group discussions, and surveys. The work shows that the regulatory response of the state is primarily driven by the government's political views and regulating agencies have had little independent role in the evolution of microfinance institutions in Bangladesh.

The optimism provoked by Myanmar's political reforms in 2011 and 2012 has now given way to a sense that the uneven nature of change in this nation of 54 million has led to instability and uncertainty. The liberalization of critical sectors and expansion of certain freedoms, such as political and legal opportunities for expression and mobilization, contrasts with the entrenchment of structural problems. It has become difficult to tackle ethnic marginalization and conflict, over-dependence on natural resource extraction, inadequate public services, and problems of under-capacity in the civilian bureaucracy. The result is the build-up of a toxic environment in which classism, racism, and bigotry threaten to rend Myanmar's already delicate social fabric. The contributors to this volume bring unique perspectives and methodologies to bear to unravel Myanmar's tangled challenges. Whether it is through studying corruption by analyzing the country's real-estate bubble, assessing civil society advocacy capacity against extractive industries, or gauging the strength--and surprising weakness--of Myanmar's military, the volume employs unconventional approaches and analytical rigor to address a fundamental question: is Myanmar itself unraveling?

The Malaysian National Higher Education Fund Corporation (PTPTN) was set up in 1997. Since then, it has accumulated a massive debt amounting to RM40 billion in principal plus RM13 billion in interest. All these are guaranteed by the Malaysian government.

It is now the biggest provider of student loans in the country and continues to play a very important role in catalysing socio-economic mobility, especially among the ethnic Malays which is the majority community in the country. However, the business model employed by PTPTN is irrational and unsustainable. It borrows from the financial market at, on average, 4 to 5 per cent, and lends to students at 1 per cent. No serious effort has been made to revamp this model, and all public discussions around it have been driven by political populism. The biggest challenge is the low repayment rate. This problem has been ignored because Malaysian politicians of all colours have wanted to maintain popularity. Collecting debt is certainly not popular.

Collecting debt is certainly not popular.
PTPTN, under a new leadership since mid-2018, gathered and developed ideas on how to reform their organization. These ideas have been presented to various

levels of government, including to the Cabinet in early 2020.
PTPTN must be reformed to avoid its debt from inflating further. Whether the Malaysian government has the much-needed political will to push through the reforms is a question yet to be answered.
