As poverty and unemployment deepen in contemporary South Africa, the burning question becomes, how do the poor survive? This title provides a compelling answer. Based on intensive fieldwork, it shows how many African households are on the brink of collapse. That they keep going at all can largely be attributed to the struggles of older women against poverty. They are the fulcrum on which household survival turns. The title describes how households in two different areas in KwaZulu-Natal are sites of both stability and conflict. As one of the interviewees put it: 'We eat from one pot and should always help each other.' Yet the stability of family networks is becoming fragile because of the enormous burden placed on them by unemployment and unequal power relations. Many of the households are extremely poor, relying on a total monthly income of less than R800. People live on little more than maize meal, tea and sugar. However, the title also demonstrates that they are not passive victims of poverty. Women, in particular, show impressive qualities of energy and resourcefulness. They engage in a number of informal sector activities, and many are active in a range of faith, and community and home-based care associations. Eating from One Pot draws on Amartya Sen's notion of co-operative conflict to argue that in times of crisis there is more conflict than cooperation in the poorest households. Poverty seriously undermines the collective character of households and creates divisions along generational and gendered lines. The title documents the humiliation many feel at the loss of their role as provider, and the resulting escalation of domestic violence and alcohol abuse. Sarah Mosoetsa conducted more than 100 intensive interviews. In the first three chapters she provides a vivid account of individual lives, perceptions and experiences. The case studies are then discussed in relation to the restructuring of the country's welfare and social policies, and the extension of social grants. Mosoetsa argues that these policies shape the livelihoods that people pursue in order to survive under desperate conditions, but fail to address the root causes of poverty and inequality.

The mainstay of the title is a choice selection of ERE case studies done over the last few years and a discussion of the political and ethical contexts of economic development.

Existing data on income and growth in sub-Saharan African countries are unreliable, even seriously misleading. The author provides the first systematic analysis of the level, direction and causes of the errors, looking at a range of African countries, from Benin to Zambia, including South Africa. He then describes why these errors matter. What seem like dry numbers actually have a huge impact on the welfare of these developing countries. Economic growth rate estimates and per-capita income statistics are vital for local governments and for economic aid. Jerven's research suggests that data supplied by national records and statistical offices substantially misstate the actual situation. As a result, scarce economic aid is misapplied, policymakers' attempts to improve their citizens' lives are frustrated, and donors have no accurate sense of the impact of their aid. Jerven explains what can and should be done to improve the guidelines for both the production and use of statistics.

Public Works Programmes (PWP) are widely implemented throughout Asia, Latin America and Africa, often with funding from major international donor agencies. They are perceived to present a 'win-win' policy option, providing employment to the chronically poor while also creating assets for the state, and in this way offering a welfare transfer which is also a tangible economic investment. The prevailing view among donors and government agencies with responsibility for social protection is that Public Works Programmes are preferable to other measures to assist unemployed people living in chronic poverty. But is this view in fact correct? This book critically explores the concept of the Public Works Programme (PWP) and interrogates its social protection performance in the context of chronic poverty. It reviews over 200 PWPs in eastern and southern Africa using original research drawn from extensive field analysis, interviews and survey work, and examines case studies of six international PWPs - in India, Argentina, Ireland, Ethiopia, Indonesia and the USA. The author explores the function and limitations of PWPs, and outlines major programme choice and design issues, drawing lessons from the international context, and challenging the assumptions underlying these policy preferences, thus opening the way for more informed and appropriate policy selection. The book makes a case for a reconsideration of the function of PWPs in the current social protection discourse, and argues that the current PWP approach may not look so attractive from the beneficiary perspective.

It was in the late 1980s that the concept that Frederik List coined as the 'National Political Economy of Production' took off again with different thinkers writing about the peculiarities and distinctions of the Japanese, American, British, German, East Asian Tigers and other varieties of system construction. Freeman defines National System of Innovation as 'the network of institutions in the public and private sectors whose activities and interactions initiate, import, modify and diff use new technologies.' Richard Nelson defines it as 'a set of institutions whose interactions determine the innovative performance of national firms. Lundvall defines the system of innovation as the 'elements and relationships which interact in the production, diffusion and use of new and economically useful knowledge and are either located within or rooted inside the borders of a nation state.' The normative assumption is that those nations that succeeded in building economic strength relied on the science, engineering, technology and innovation capability that made them to achieve an innovation advantage to put them ahead in the world, acquiring national or regional economic leadership as the case may be depending on what level of analyses is selected to look at particular failure, success or progress they made. In this volume we have a glimpse of how in different African economies from Ghana, Uganda, Kenya, South Africa and Nigeria specific cases have been taken to explore how systems of innovation is evolving.

Despite a long history of regional integration and a multiplicity of regional organisations in southern Africa, the effect of regional integration on economic growth and poverty reduction remains debatable or elusive. This causes many to doubt whether regional integration is in actual fact an effective poverty-reduction strategy. Accordingly, the focus of this book is to explore and analyse whether specific Southern African Development Community (SADC) trade integration policies, especially the trade liberalisation regime, have produced economic growth and reduced poverty in the region. Acting as a Sorcerer's Apprentice, the West incorporated 1.3 billion Chinese and 1.2 billion Indians into the world's labour equation within a context of lower production costs. This resulted in erosion of its competitive capacity and social stability, while greatly benefiting developing economies, many of which were able to emerge with unprecedented speed. With China as the main engine, the developing economies have become increasingly integrated, sustaining in the process a fundamental part of the global trade growth. However impressive the economic success of Penang has been over the past four decades, structural conditions in the region call for a fundamental reconfiguration of this Malaysian state's competitive advantage. In the 1970s, the ageing entrepôt transformed itself into a manufacturing hub for the electronics industry and a well-known tourist site. This outward-looking model of economic growth has underpinned Penang's economic development up until the present. The question that now arises is whether Penang's present mode of development will continue to be effective, or whether it will have to transform itself. First, Malaysia in general, and Penang in particular are caught in a middle-incometrap. Second, while the evolving weight of the global economy is shifting towards Asia, many of its emerging powers are competing with Penang in areas where it formerly excelled.
