From Skins to Robes and Wigs by Justice John Bosco Katutsi is a collection of several jurisprudence cases, in Uganda, Sierra Leone, and Liberia, life breakthroughs, breakdowns and ups, threats and challenges of a 38-year judicial service. It is also, an 81-year-life autobiography and a thrilling experience for a reader.

The book sheds some light on his trial of the First Lady Mama Mariamu Amin as one of his first cases as a young magistrate in Mbale to heading a tribunal in Masaka District to handle economic crimes under President Idi Amin to a life in private law practice after Katutsi's resignation from court following Obote's return to power. And, finally getting back to making landmark judgments in some of the most publicised and anticipated cases in the Museveni regime. The book also contains judgments such as those in the trial of John Sanyu Katuramu for murder of Prince Charles Happy Kijanangoma; the bail application for Dr Kizza Besigye; and the 21 People's Redemption Army suspects that led to the Black Mamba invasion of the High Court and later the strike of the judiciary; the trial of Dr Besigye for rape in 2006 and the Teddy Seezi Cheeye conviction. On retirement, Justice John Bosco Katutsi presided over courts in Sierra Leone and Liberia also making landmark anti-corruption judgments. In her fiction debut, Doreen Baingana follows a Ugandan girl as she navigates the uncertain terrain of adolescence. Set mostly in pastoral Entebbe with stops in the cities Kampala and Los Angeles, *Tropical Fish* depicts the reality of life for Christine Mugisha and her family after Idi Amin's dictatorship. Three of the eight chapters are told from the point of view of Christine's two older sisters, Patti, a born-again Christian who finds herself starving at her boarding school, and Rosa, a free spirit who tries to "magically" seduce one of her teachers. But the star of *Tropical Fish* is Christine, whom we accompany from her first wobbly steps in high heels, to her encounters with the first-world conveniences and alienation of America, to her return home to Uganda. As the Mugishas cope with Uganda's collapsing infrastructure, they also contend with the universal themes of family cohesion, sex and relationships, disease, betrayal, and spirituality. Anyone dipping into Baingana's incandescent, widely acclaimed novel will enjoy their immersion in the world of this talented newcomer.

Beautyful Problems is set in several parts of Uganda and Kenya. It follows the lives of two young lawyers starting their legal careers. The lead protagonist Goldie works in a law firm and his friend Victor in a bank. Whereas they both share ambition, it is the contrast between the maverick lifestyle of Goldie and his friend's conservatism that sets the tone. Goldie starts a relationship with a young lady still at the University and while he plans to marry and settle with her, the sudden change in fortunes at his workplace checks to see if the relationship can survive the temptations of materialism. Goldie's sexual trysts overlap his loyalty and friendships, but the stresses of work and excessive indulgences are all but light trials. The story crashes into a cornucopia of political undertones when Goldie's work brings him the most unlikely client, a member of a political outfit. Personal relations and proximity to the players in the subplot guarantee that everybody is sucked into the sweeping storm, with revelations of betrayals and connections that are bound to change everyone's life forever.

Examines the historical, political, religious, and social dynamics of Muslim minority status in Uganda, and important themes of pre- and post-colonial political community, religion and national identity.

Between 2012 and 2016 several Muslim clerics were murdered in Uganda: there is still no consensus as to who was responsible. In this book Joseph Kasule seeks to explain this by examining the colonial and postcolonial history of the Muslim minority and questions of Muslim identity within a non-Muslim state. Challenging prevalent scholarship that has homogenized Muslims' political identity. Kasule demonstrates that Muslim responses to power have been varied and multiple. Beginning with the pre-colonial political community in Buganda, and Muteesa I's attempted Islamization of the country using Islam as a centralizing ideology, the author discusses how the political status of Islam and Muslims in Uganda has been defined under successive regimes. Muteesa I's Islamization faltered when Christianity entered Buganda in the latter half of the 19th century, resulting in division between Muslim and Christian sections. The colonial period created a new type of political project that defined the Muslim question as one of representation, and Kasule discusses how this laid the foundation for a politics of Muslim containment within a predominantly Christian power. He examines contrasting urban-based Muslim organizations and rural expressions of Islam; tension between representative claims of Muslim leaderships within the demand for Muslim autonomy; and the rise of new reform groups. As these splits turned violent, 'new' Muslim 'publics' emerged around opposing centres of Muslim power which sought different resolutions to their minority situation.

The infamous "Scramble for Africa" resulted in random and unlikely borders that remain today. The West partitioned territory for the sake of its short-term goal of influence or mastery. They gave little thought to the long-running consequences for the Africans themselves. This arbitrary carving up of Africa, the colonial policy of divide and rule, and the resultant segmental cleavages in most post-colonial African states may be blamed for the horizontal inequalities, conflicts, and insecurity rampant since independence. In Uganda, as in many other African countries, the most evident of such cleavages have been tribal and ethnic. Recently there have been calls for constitutional reform that would devolve power to the tribal regions and revive the idea of federalism which was the organizing principle in the immediate aftermath of independence. This book highlights the dynamics of ethnic politics in the post-independence sub-Saharan setting in general and the background, meaning, and relevance of the debate on ethnic federalism in Uganda, in particular. Part of the book covers Vick Lukwago Ssali's own experiences growing up in an independent but troubled Uganda. However, its central thesis is based on the voices of selected samples of ordinary people in ten different tribal areas of Uganda and what they comparatively think about the issue of federalism.
