The Master from Mountains and Fields is a fully annotated translation of the prose texts from the "collected works" of Sŏ Kyŏngdŏk (1489–1546), an influential Confucian scholar from the early Chosŏn period (1392-1910). A native of Songdo (also known as Kaesŏng) in present-day North Korea, Sŏ has loomed large in the Korean cultural imagination and appeared as an exceptional sage and popular hero in numerous tales, dramas, and films, yet his writings are little known outside the academic milieu.

Also called Master Hwadam, Sŏ embodied an archetype of the secluded scholar who remains hidden in "mountains and forests" to devote himself to his studies. Held in esteem in both South and North Korea today (a notable exception in contemporary studies on Chosŏn Neo-Confucianism), Sŏ and his ideas about Vital Energy influenced the great Korean Neo-Confucian debates of the sixteenth and seventeenth centuries surrounding the psychophysiological origins of morality as well as various non-orthodox intellectual trends in the late Chosŏn. His thought is fundamentally rooted in the cosmology based on the exegesis of the *Book of Changes* and follows the teachings of various early Chinese Neo-Confucian thinkers; it presents a vivid example of the eclectic nature of ideas and intellectual trends coexisting within what is generically called Neo-Confucianism out of convenience.

This volume presents the first English translation of all prose writings attributed to Sŏ and most of the peritexts from his posthumously published collection *Hwadam chip*. It reflects the importance of literary compilations *(munjip)* in the intellectual history of Chosŏn and the complex process of the making of Confucian masters in Korea. Sŏ's prose works are concise and diverse and offer a glimpse at an author who thwarts stereotyping; an introduction and annotations provide further context. The lengthy endnotes that accompany each text make this a useful handbook for anybody interested in Chosŏn Korea and Confucianism, from students in East Asian and Korean studies to specialists in literary Chinese *(hanmun)* or East Asian intellectual history.

1st Collection of Short Stories on Jeju April 3 Incident Published in 1957 as a Way of Informing the World.

Kim Sok-pom has devoted his writing career to raising awareness of the Jeju April 3 Incident through literature. Death of a Crow (1957) marked the beginning of his campaign as his leading work and the one that earned him recognition. By writing about the uprising, he delved into history and human problems. Chronicling a variety of lives in the event was also how he gained understanding of this world.

"Bak-seobang, Jailer," "Death of a Crow," and "Gwandeokjeong," a series of closely intertwined works in this book, depict Jeju amid the massacre that lasted for about a year from summer 1948; "Death of a Crow" and "Gwandeokjeong" are about the same person. Though "Feces and Freedom" and "A Tale of a False Dream" did not deal with the uprising directly, they show why the author studied the massacre and his opinions of it.

An Ethnic Korean Woman in Japan Struggles to Find Her Identity.

When she utters "our country", which does she mean, Korea or Japan? Lee Yang-ji's short stories "Yuhi" and "Nabi T'aryŏng" portray the agony and inner conflict of Zainichi (ethnic Koreans residing in Japan) who find themselves considered strangers both in Korea and Japan.

"Yuhi" features the eponymous protagonist going to Korea in search of her roots as does Aiko, the main character of "Nabi T'aryŏng". Both women grow frustrated after realizing that they are considered marginal persons who can be neither Korean nor Japanese.

The two works vividly show traces of the writer's agonizing search for her identity and feelings of ambivalence as a second-generation Zainichi. Central to the Korean pansori musical storytelling tradition is Chunhyangga, an eighteenth-century love story involving the romance between Yi Mongryong, heir to a noble family, and Chunhyang, daughter of a courtesan. In Chunhyang, novelist Jin Renshun reimagines that romance, challenging its premises and taking it in a radically new direction.

Chunhyang is the story of a mother and a daughter's quests for independence and self-worth in a world where women are too often confined and devalued. Chunja's Nanjing explores in depth the tragic events of the 1930s dubbed the "Tragedy in Deer Valley" in Jiandao, a historical border region along the north bank of the Tumen River in China's Jilin Province with many ethnic Koreans, in the beginning of the novel and the "Rape of Nanjing" in Nanjing, China, at the end. The novel also discusses the plight of women forced into sexual slavery by the Japanese imperial army before and after World War II.

Though a novel, this book intertwines the truth and pain of the past to create a story based on historical materials such as statements from Chinese women forced into sexual slavery by Japan, archival documents about the relevant incidents, and a variety of reports.
