Largely by reason of its isolation, the tiny volcanic island of Tikopia in the South Pacific, has managed to retain its traditional Polynesian culture far more than most Pacific islands.

Almost seventy years after the life of the island community was detailed by anthropology student Raymond (later Sir Raymond) Firth, the present author, Julian Treadaway, made several visits to Tikopia, sharing the life of his time, and noting remarkable continuity with the time of Firth's visits and even before.

Comparing the present with the past observed by earlier visitors, Treadaway's stories provide a fascinating account of this continuity and change.

With a meticulously observant yet emphathetic eye and an easy style, Treadaway records the day-to-day life of the community – detailing the distinctive ceremonies; everyday activities; and unique Tikopian customs of, amongst other things, crawling into houses and ritualistic crying. Through these stories he poses the question that hangs over Tikopia and all such communities: how best can traditional societies benefit from the modern world without completely losing their distinctive culture and identity?

Fiji was a strategic outpost on the northern approaches to New Zealand and one of the vital stepping stones across the Pacific that enabled United States military forces to reinforce Australia in the dark days of World War II and later to create a base for the counter-offensive against Japan.

The capture of Fiji would have put large areas of the north island of New Zealand within bomber range and cut the 'reinforcement line' to Australia. Consequently, New Zealand developed Fiji's fixed defences, expanded the Fiji Military Forces, and eventually sent the 3<sup>rd</sup> NZ Division to its defence.

At the height of the Japanese threat, most of the New Zealand forces were replaced by the United States Army and Air Forces and by the end of 1942 there were about 40,000 United States, New Zealand and Fiji servicemen defending the main island of Viti Levu.

This is the story of why Fiji was important to the Japanese and how and why the Allies developed its defences to repel a possible invasion.

Samoa became an independent state on 1 January 1962. In moving toward independence, Samoans made it clear that they wanted a political structure that reflected custom and tradition as well as democracy. The post-independence period demonstrated the practical difficulty of reconciling the two - both of which are provided for in Samoa's constitution.

In Democracy and Custom in Samoa: An uneasy alliance, So'o examines the coexistence of the two systems of governance. He concludes that, while there has been significant progress toward democracy - with positive and negative impacts of indigenous institutions, values and practices - it has been restricted by the persistence of customary ideals.

The mixing of tradition and democracy is seen as a phase in the process of continuous social and political change, in which practices and values that no longer fit current circumstances are discarded for more relevant and appropriate ones.

Democracy and Custom in Samoa: An uneasy alliance will be rewarding reading for anyone interested in the interaction between old and new cultures, and in social and political change in Samoa, the Pacific and elsewhere.
