The BEI – World Bank investment climate report indicates that compared to China, India and Pakistan, Bangladesh is falling behind. The incidence of corruption is far greater, the quality of infrastructure poorer and the performance of key government departments or agencies less satisfactory. Added together, the cost of doing business in Bangladesh today compared to other countries in the region is considerably higher. One obvious way of improving the investment climate would be substantially reduce the cost of doing business in Bangladesh by eliminating or reducing corruption in key government departments or agencies and introducing changes, which would eliminate delays and provide for greater transparency.]
