The adivasi groups are aborigines of the land and for centuries they protected forests as custodians for them forest is living the giver of life and the seat of spirituality. They lives fairly a unchallenged life till the advent of the British Regime. They encountered tremendous changes with the British Annexation in early 19th century, then the partition of 1947 and finally with the Liberation war of 1972. Before the British annexation the most of the adivasis maintained fairly autonomous jurisdiction under their chiefs. The special administrative arrangements for many of the adivasi groups such as the Chittagong Hill Tract Manual of 1900 and the Partially Excluded Areas of Mymensingh introduced during the British Regime have gone by now. They were facing relocation of population in the areas once they formed absolute majority they increasingly need to adjust with attitudes of the ruling class who often show rigidity accommodating differences of customs, believes, culture, language and way of lives. So they have to be bilingual even at one stage they were forced to give up their identity as district ethic groups but become Bengalis.]

[This review provides mixed messages. As far as men's reproductive health services are concerned, to date little effort has been made to achieve the ICPD agenda. However, the importance and urgency for addressing the needs of men's reproductive health are now better understood both for the sake of women's reproductive health and for man themselves. A number of issues and action points have been identified for immediate program interventions. These issues could be taken as benchmarks for future evaluation by those who are concerned with carrying ahead the ICPD agenda. The review also identified various knowledge gaps particularly related to service delivery, sexuality and the sexual behavior of men, and the social constructs that condition their behavior. It is hoped that the book will work as a stimulus and some of these topics will be immediately addressed by the research community, both to understand these aspects of human behavior and also to facilitate the work of program managers who are looking for guidance and accurate information to strengthen reproductive health services for couples.]
