Exorcising Ancestors Conquering Heaven : Himalayan Rituals in Context / Brigitte Steinmann, Mukta Singh Tamang and Thuden Gyalchen Lama Kathmandu: Vajra Books, 2020 xx, 380p. Includes Bibliography 9789937624039 \$ 40.00 / PB 468gm.

This volume is a first attempt at gathering together, translating, describing and analysing an immemorial textual and oral Nepalese Buddhist heritage, doomed to disappear: a most antique form of veneration of major figures of the Buddhist religion of the Tamangs, based on Tibetan corpus. The analysis is centered around the recreation and final dissolution of both ferocious and pacific images of their gods and ancestors. Multiple dramas and rehearsals featuring the complex rules of the society and all the obstacles encountered by people in their day to day lives, are played theatrically under the guidance of the Head rnyingmapa Lama and/ or the Bard. Books, dramas, recitations, speak of fiercely combatting hordes of demons, enemies of the group, of eliminating a scapegoat and of using for this all the resources of a very high-mountain environment, though far away in fact from where the ceremony in question is performed. People claims loud and clear to have descended from kings who came from the top of an original mountain situated in the centre of the world and touching the sky Spinilarly, Funeral rites founded on a conceptualisation of the phases of death, and Teachings for the laity recited by the local bard, suggest that today's Tamangs' ancestors may well have been contemporaneous with ancient Mongolian societies, all of them adepts of the old Bon religion and prior to periods when the great literature of the northern Treasuretexts *gterma* disseminated in Nepal from the seventeenth century onwards, was introduced. This long-term work is the result of a collective effort bringing together the skills of researchers, ethnologists and historians, passionate about the world of these Buddhist populations of Nepal.

Instead of focusing on advancing its interests, Nepalese stakeholders have often compromised them while serving the interest of external powers and dislodging or defending the system and government.

Without civilian control over the military, democracy cannot effectively control armed insurgency and deliver political stability. "Prithivian Trinity" could be a mantra to deter or defeat external threats and critical internal challenges. The government's handling of the Maoist insurgency was a political mess. Had

the RNA leveraged the palace-military relations for its preemptive mobilization in Dunai, subsequent major events like Holeri, Dang, and the dissolution of the twin-pillar system would have been prevented. The sovereign monarch is quite an old concept, hence became untenable in 2006.

India's core interests in Nepal are to continue with the 1950 Treaty, maintain influence in internal affairs, prevent security threats from the Nepali front, recruit youths for Gorkha regiments, maintain an open border regime, and harness water resources.

In this tome – 'From the Bagmati to the Potomac: In the Vortex of Change and Upheaval' presenting the latest compilation of write-ups by consultant editor emeritus, M.R. Josse, spanning the period from 30 June, 2020 to 19 January, 2021. Of the 26 thoughtful and incisive pieces contained herein, all of which have been published in the print editions of The People's Review weekly, 14 are essays drafted by the veteran columnist in Kathmandu and 12 are think-pieces penned from Gaithersburg, in the U.S. state of Maryland. The 'Bagmati and the Potomac' in the volume's title are metaphors for Nepal and the United States of America. Zangh Zhung Nyengyud Ngondro : The Preliminary Practices to Dzogchen According to the Oral Transmission of Zhangzhung as Taught by Ponlob Tsangpa Tenzin Rinpoche / Ponlob Tsangpa Tenzin Rinpoche (Ed) Gideon Makin (Translator) Dr. Sangmo Yangri Kathmandu: Vajra Books, 2021 196p. 9789937624091 \$ 35.00 / PB 224gm.

In this book Ponlob Rinpoche charts the course of the nine practices known in the Tibetan Bon and Buddhist traditions as Ngondro. Because Ngondro teachings hardly assume any prior knowledge, they are suitable for introducing Buddhist practices in general, as well as some key concepts of the underlying world view. For instance, before a meditation session a practitioner performs the three Ngondro practices known as Guru-Yoga, Refuge, and Bodhichitta. In this book one finds an orderly and detailed explanation of what these practices mean, as well as practical instruction on how to perform them.

Ngondro (literally: "that which goes before") is, firstly, a preliminary. The role of the nine practices is to purify the mind in preparation for higher practices - in this case Dzogchen - like cleaning a cup before pouring fresh milk into it. Second, Ngondro is also the foundation for more advanced practices. Skipping it is like trying to jump to the top of a building instead of using the stairs. Unless one takes the stairs of Ngondro one by one, one's Dzogchen practice will not become stable and beneficial.

Third, even a practitioner who has come to Dzogchen after climbing the stairs of Ngondro still needs it as a support. One's Dzogchen practice may fail to progress and become stagnated; practicing Ngondro is the remedy to this. As Rinpoche puts it, thinking to oneself "I have been practicing Dzogchen for a long time. I hold a high view. I've done Ngondro practice already" is misguided. Both Ngondro and Dzogchen are indispensable, like the two wings of a bird. http://www.marymartin.com/web?pid=781317
