Cambodia emerged as a hybrid Hindu state in the Mekong Delta during the 6th century. Three centuries earlier, a Chinese visitor recorded that 'local people lived in stilt houses covered in thatch, cultivated rice and sent tributes of gold, silver, ivory and exotic animals to the Imperial court'. These early wooden dwellings were typically located on network of canals connecting sea and land routes used by Indian traders in the ancient kingdom, which the Chinese referred to as Funan.

In the 21st century, most Cambodians reside in the rural areas. These proud farming communities live in villages of wooden thatched houses, growing rice or produce for both export markets. This unbroken tradition of domestic and functional, rather than public buildings - has started to disappear, along with Khmer carpentry skills. The finest examples of these houses are increasingly neglected despite being an important part of Cambodia's vernacular architectural heritage.

Tens of thousands of garment workers in Cambodia will struggle to repay microfinance debts during work stoppages and factory suspensions caused by COVID-19, creating a mounting human rights crisis as they struggle to feed their families and hold onto their land under immense pressure from microfinance institutions (MFIs). Without immediate debt relief, many of these workers will resort to selling their land or their homes, eating less food or taking out even more loans to repay their debts.

In Worked to Debt, a joint briefing paper between the Cambodian Alliance of Trade Unions (CATU), the Center for Alliance of Labor and Human Rights (CENTRAL) and the Cambodian League for the Promotion and Defense of Human Rights (LICADHO), researchers surveyed more than 150 workers – most of them women – from three factories in Phnom Penh and Kampong Chhnang to investigate how workers were coping with their debts as hundreds of factories suspended operations as a result of the global pandemic.

Through interviews conducted with remaining family members from 30 households, LICADHO's researchers found that overindebtedness to microfinance institutions (MFIs) was the primary motivating factor for migration in the village.

Collateral Damage : Land Loss and Abuses in Cambodia's Microfinance Sector : A Report

More than 2 million Cambodians currently have a loan with a microfinance institution, or MFI. Levels of debt have skyrocketed in recent years, leading to a number of human rights abuses, including coerced land sales, child labour, debt-driven migration, and bonded labour, according to a joint report from the Cambodian League for the Promotion and Defense of Human Rights (LICADHO) and Sahmakum Teang Tnaut (STT).

Collateral Damage: Land Losses and Abuses in Cambodia's Microfinance Sector details the size and scope of Cambodia's MFI sector and seeks to highlight the human rights abuses that researchers discovered. The research spans 10 communes in 4 provinces as well as Phnom Penh and features seven detailed case studies of abuses, chosen from the 28 MFI clients who suffered human rights abuses that were interviewed by researchers. MFIs in Cambodia charge high interest rates, require land titles as collateral,

and target poor clients who are vulnerable to land loss. This predatory form of lending, which has led to immense profits for MFIs and their foreign lending partners, has negatively impacted the land tenure security of Cambodians, especially vulnerable communities. Poor farmers should not be subjected to predatory financial activity, but rather have access to sustainable and community-managed financing. LICADHO and STT call on the Cambodian government, microfinance institutions and international investors to reform these practices and ensure that Cambodians are no longer forced to sell land and suffer human rights abuses in order to pay their debts.

Thousands of Cambodian children were adopted overseas between the late 1980s and 2009. During that time it emerged that many of the adopted children were not orphans but had parents who placed them in orphanages because of extreme poverty. Their parents placed them there on the understanding that they would return home at a later date. They did not consent to their children's adoption. Instead, orphanage directors, with the help of local authorities, created documents falsely stating that the children were orphans or had been abandoned.

When evidence of this came to light, many countries suspended the adoption of children from Cambodia and in 2009 Cambodia itself suspended them. The parents of the children adopted abroad were often illiterate and lacked awareness of their rights or of where to turn to for help and so were unable to find out what had happened to their children.

In a new report Cambodia's Stolen Children: Fraud and Corruption in the Inter-Country Adoption System released today, LICADHO describes the cases of several birth mothers who recently approached the organisation seeking help finding their children who had been adopted overseas in the 2000s.

The Cambodian League for the Promotion and Defense of Human Rights (LICADHO) today is releasing "The Fight for Freedom: Attacks on Human Rights Defenders, 2018-2020"."The Fight for Freedom" is not an exhaustive list of all attacks targeting human rights defenders since the beginning of 2018. Instead, it highlights a number of high-profile cases where human rights defenders have been targeted for intimidation, arrest or imprisonment while trying to peacefully exercise their rights to association, assembly and expression as guaranteed both in Cambodia's constitution and under international law.

An annexe spanning the beginning of 2018 until the month leading up to this report's publication draws upon the work of LICADHO's human rights monitoring project to detail a broader, though still not comprehensive, pattern of attacks and threats against human rights defenders in Cambodia.

In the three years since LICADHO last released a report on attacks on human rights defenders carried out by authorities, the government has overseen the dissolution of the main opposition Cambodia National Rescue Party (CNRP) and continued its repression of non-political human rights defenders and activists.

The arrest and imprisonment of more than a dozen human rights defenders in the second half of 2020 has capped off three years of increasing repression of peaceful advocacy and activism by the ruling Cambodian People's Party (CPP). But despite the ruling party's unyielding grip on the nation's civil and political institutions, Cambodians across the country persist, standing up to demand and defend their fundamental human rights.

Demographics of Population Ageing in Cambodia, 2012 Phnom Penh: National Institute of Statistics, Ministry of Planning, 2012 1v. \$ 35.00 / PB 266gm.

A major emerging demographic issue of the 21st century is the ageing of population as an inevitable consequence of the demographic transition experienced by most countries. Across the world, declining fertility and increased longevity have jointly resulted in higher numbers and proportions of older persons 60 years and above.

In Cambodia, the proportion of population aged 60 years and above was 6.34 per cent in 2008 (848,911) and expected to increase to 11.01 per cent (2,024,171) by year 2030. The more developed provinces in the plain region like Kampong Cham and a few others in Tonle Sap region like Banteay Meanchey, Battambang, and Siem Reap have experienced demographic transition ahead of others and therefore are growing older faster than other provinces.

This paper explores the demographic profile of senior citizens aged 60 years and above in Cambodia using the 2008 census data and projections up to 2030 (only 22 years from now) to build a knowledge base that will help to better understand the implications of changing population age and sex distribution for development planning.

Some other cross-cutting issues that may hinder key developments in the region have also been featured, including the ongoing negotiation on the Code of Conduct in the South China Sea, the rising economic tiger – India - and its economic influence in the Indo-Pacific, the Korean Peninsula security issue, and the Global Gateway Initiative, among others.
