Vanishing Giants: Elephants in Asia is a photographic book which looks at the Asian Elephant, their struggle to find a place in a rapidly urbanising world, and the lives of the people who exist alongside them. At a time when its close relative, the African elephant, is flourishing, the Asian elephant is imperiled as never before. The demands of industry and agriculture, populations that are growing exponentially, illegal logging and other environmental degradation: all conspire to rob this king of beasts of his birthright. Asia's wild elephant population now hovers at somewhere below 40,000 in the 13 countries of South and Southeast Asia, which make up their habitat.

The main aim of this series is to catalogue, describe and illustrate in detail all the extant and extinct species of angiosperms (flowering plants) which have been recorded to occur in Singapore. This totals about 2400 species in 173 families. The series consists of individual booklets for each family, and an introduction containing information on the palaeogeography, human impact, climate, geology and soils, biogeography, vegetation and conclusions. The individual family treatments are written in the traditional style of a Flora, i.e. with the sections on the nomenclature, morphological description, distribution, ecology, uses, other notes and references for each taxon. Scientific line drawings and/or black and white photographs are also included.

The series should be of interest to agronomists/horticulturists, botanists, ecologists & other scientists in fields peripheral to botany, staff of herbaria, hobbyists & gardening enthusiasts, libraries and plant systematists/taxonomists.

The essays in Knowing Southeast Asian Subjects ask how the rising preponderance of scholarship from Southeast Asia is de-centering Southeast Asian studies in the United States. The contributions address recent transformations within the field and new directions for research, pedagogy, and institutional cooperation.

Contributions from the perspectives of history, anthropology, cultural studies, political theory, and libraries pose questions ranging from how a concern with post-colonial and feminist questions of identity might reorient the field to how anthropological work on civil society and Islam in Southeast Asia provides an opportunity for comparative political theorists to develop more sophisticated analytic approaches. A vision common to all the contributors is the potential of area studies to produce knowledge outside a global academic framework that presumes the privilege and even hegemony of Euro-American academic trends and scholars.

Sixty years after the end of World War II, the political and social fallout from the War is alive and divisive, as scholars in this volume show. One example is how former Japanese Prime Minister Junichiro Koizumi's visit to the Yasukuni Shrine prevented China, Japan and South Korea from sitting down together to talk about Northeast Asian integration, and wider Asian integration. Another example is the question of comfort women. Former Japanese Prime Minister Shinzo Abe's statement - that there is no evidence that Japan's government or army forced women to work in military brothels during the War appeared to go back on a 1993 apology for the comfort women. How such issues of history are dealt with by countries of this region has an effect on contemporary relations among the major powers contending for leadership in East Asia.

Secret Trades, Porous Borders: Smuggling and States Along a Southeast Asia Frontier, 1865-1915 / Eric Tagliacozzo Singapore : NUs Press, 2007 Co-Published with Yale University Press 438p. 9789971693855 \$ 25.00

Over the course of the half century from 1865 to 1915, the British and the Dutch delineated colonial spheres in the process of creating new frontiers. This book analyzes the development of these frontiers in Insular Southeast Asia as well as the accompanying smuggling activities of the opium traders, currency runners and human traffickers who pierced such newly drawn borders with growing success. This book presents a history of the evolution of this 3,000 km frontier, and then inquires into the smuggling of contraband: who smuggled and why, what routes were favoured and how effectively the British and Dutch were able to enforce their economic, moral and political will. Examining the history of states and smugglers playing off one another within a hidden but powerful economy of forbidden cargoes, the book also offers new insights into the modern political economies of Southeast Asia.

Water, in its many guises, has always played a powerful role in shaping Southeast Asian histories, cultures, societies and economies. This volume, the rewritten results of an international workshop, with participants from eight countries, contains thirteen essays, representing a broad range of approaches to the study of Southeast Asia with water as the central theme.

As it was exposed to the sea, the region was more accessible to outside political, economic and cultural influences than many landlocked areas. Easy access through sea routes also stimulated trade from an early age. However, the same easy access made Southeast Asia vulnerable to political control by strong outsiders. The sea is, moreover, a source of food, but also of many hazards.

At the same time, Southeast Asian societies and cultures are confronted with and permeated by 'water from heaven' in the form of rain, flash floods, irrigation water, water in rivers, brooks and swamps, water-driven power plants, and pumped or piped water, in addition to water as a carrier of sewage and pollution.

Finally, the volume deals with the role of water in classification systems, beliefs, myths, illness and healing.

In 1864, when this book was written, the Straits Settlements were eager, that they 'should no longer remain the dependency of a dependency', but to be directly administered by the colonial office and not via India. Therefore the book emphasizes all positive aspects of Singapore for the empire:

J. Cameron describes as well with enthusiasm and in great detail all facets of social and natural life in tropical Singapore: the various colourful cultures, the mighty jungle, opium smoking, amok assaults, the exotic fruits, the growing city and the busy harbour.

Security and economic imperatives are increasingly intertwining the destinies of Southeast Asia and South Asia, making it necessary for scholars on both sides to deepen their understanding of each other's regions. This collection of papers, first presented at a Dialogue between the Institute of Southeast Asian Studies in Singapore and the Observer Research Foundation of India in March 2006, provides perspectives from India and Singapore on some of the major security and political issues facing the two regions. The subjects covered include regional integration trends as symbolized by the first East Asia Summit, the roles of the major powers, maritime security and naval deployments in the Indian Ocean region, and political and security developments within Southeast Asia.

The Asia-Pacific Security Lexicon (Updated 2nd Edition) /David Capie, Paul Evans Singapore : Institute of Southeast Asian Studies, 2007 248p. 978-981-230-723-1 \$ 27.90

The ending of the Cold War opened a new debate across the Pacific about the meaning of security and the new regional multilateral institutions that were beginning to emerge.

The first edition of the The Asia-Pacific Security Lexicon, published in 2002, identified and defined the key concepts and ideas central to security discourse in the region.

This second edition updates all of the entries and examines the origins and meanings of some of the new terms in common usage in a different historical setting, among them "terrorism", "pre-emption", "preventive war", "a la carte multilateralism", "coalition of the willing", and China's "peaceful rise". And it looks at how concepts such as "human security" and "non-traditional security" have evolved and found new adherents.

Both a diplomatic handbook and theoretical exploration, the Lexicon is based on the analysis of more than 3,000 books, articles, conference reports, and speeches. It does not aim to resolve the disagreements about how words are used. Rather, it makes their evolution clearer for academics and practitioners seeking consensual knowledge.

Despite unprecedented levels of global interconnectedness, little academic attention has been paid to how governments actively deal with the challenges globalization poses for national identity. This book investigates the Singapore Government's approach to the construction of national identity and the shifting ways in which Singapore has been imagined in official discourses.

The hallmarks of Singapore's nation-building project have been the state's efforts to manage ethnic differences and ensure the economic well-being of its citizenry. Unlike other global cities which are embedded in a larger nation-state, Singapore is both a global city and a nation-state. Singapore embodies a curious contradiction: while global cities are often theorized as transient spaces, contradictorily, the nation-state needs to be bounded in order to remain viable.

This book focuses on the global/national nexus: the tensions between the necessity to embrace the global to ensure economic survival, yet needing a committed population to support the perpetuation of the nation-state and its economic success. It critically explores how the government has been responding to the challenges of globalization through policy initiatives and official rhetoric to create a "space" for affective identification with the Singaporean nation-state and how Singaporeans relate to and articulate their sense of identity and belonging to Singapore within the context of globalization.
