This book brings the ironic worldview of the Lisu to life through vivid, often amusing accounts of individuals, communities, regions, and practices. One of the smallest and last groups of stateless people, and the most egalitarian of all Southeast Asian highland minorities, the Lisu have not only survived extremes at the crossroads of civil wars, the drug trade, and state-sponsored oppression but adapted to modern politics and technology without losing their identity.

The Lisu weaves a lively narrative that condenses humanity's transition from border-free tribal groupings into today's nation-states and global market economy. Journalist and historian Michele Zack first encountered the Lisu in the 1980s and conducted research and fieldwork among them in the 1990s. In 2014 she again traveled extensively in tribal areas of Thailand, Myanmar, and China, when she documented the transformative changes of globalization. Some Lisu have adopted successful new urban occupations in business and politics, while most continue to live as agriculturists "far from the ruler."

The cohesiveness of Lisu culture has always been mysterious—they reject hierarchical political organization and traditionally had no writing system—yet their culture provides a particular skillset that has helped

them navigate the terrain of the different religious and political systems they have recently joined. They've made the transition from living in lawless, self-governing highland peripheries to becoming residents and citizens of nation-states in a single generation.

Ambitious and written with journalist's eye for detail and storytelling, *The Lisu* introduces the unique and fascinating culture of this small Southeast Asian minority. Their path to national and global citizenship illustrates the trade-offs all modern people have made, and their egalitarian culture provides insight into current political choices in a world turning toward authoritarianism.

Part 1 of this volume consists of five chapters that examine broader issues of conservation principles and approaches in historic cities of Asia. The contributions discuss various perspectives ranging from critiques of current conservation policies regarding local heritage conservation to recent trends of rapid and unplanned development of historic quarters in Asian cities. The case studies in Part 2 of this volume contextualise current debates on the role of community engagement to conserve historic urban quarters and examine diverse contexts across Malaysia, Taiwan, Thailand and Philippines. All five chapters are about real-world projects where the authors were actively involved in various roles – as facilitators, professional advisers, community leaders and coordinators, and activists. While some chapters present critical review and commentary; others provide lived experience of working with communities in preserving their local heritage. It is often seen that participatory community approaches employed by concerned authorities for heritage conservation projects based on recommendations by experts do not always aid local communities due to lack of heritage awareness and limited application of community engagement exercises. Hence, in most heritage development projects, there remains a significant divide between the authorities responsible for policy planning and the actual users of the heritage. Why does local heritage matter to communities? The contributions explored the fundamental reasons for this question and argued that heritage mean more than just mere identity, continuity and accumulated layers of memories.

The heritage is also a tool for the community coming together as one and its revitalisation, economic growth, and sustainability. The notion of heritage is not mainly about the past instead it matters to the people of the present and how they anticipate their future. It is inevitable for historic Asian cities to evolve. Moreover, for their sustainable development, it is pivotal to keep a balance between development and heritage conservation.

Book Details:

The period ca. 645-770 marked an extraordinary era in the development of East Asian Buddhism and Buddhist art. Increased contacts between China and regions to both its west and east facilitated exchanges and the circulation of ideas, practices and art forms, giving rise to a synthetic art

style uniform in both iconography and formal characteristics. The formulation of this new Buddhist art style occurred in China in the latter part of the seventh century, and from there it became widely disseminated and copied throughout East Asia, and to some extent in Central Asia, in the eighth century.

This book argues that notions of Buddhist kingship and theory of the Buddhist state formed the underpinnings of Buddhist states experimented in China and Japan from the late seventh to the mid-eighth century, providing the religio-political ideals that were given visual expression in this International Buddhist Art Style. The volume also argues that Buddhist pilgrim-monks were among the key agents in the transmission of these ideals, the visual language of state Buddhism was spread, circulated, adopted and transformed in faraway lands, it transcended cultural and geographical boundaries and became cosmopolitan.

It examines some of the neglected issues of artistic connections within the Buddhist world fostered through the movements of monks, the agency of Tang and Japanese courts, and the creation of key images and building styles. Dorothy Wong not only convincingly demonstrates the intricacies of the emergence and spread of the "Tang International Style" in the seventh and eighth centuries, but also illustrates the importance of state support in the making of a Buddhist cosmopolis during this period. Wong offers new insights into the circulation of Buddhist ideas and the contributions of Buddhist monks beyond their translation activities. The Art of Chua Mia Tee: A Portrait of a Life's Work is the first significant monograph on the artist Chua Mia Tee, marking his conferment of the Cultural Medallion in 2015. This ambitious undertaking brings together for the first time in a single volume, more than 300works of art that have anchored Chua's reputation as one of Asia's foremost Realist artists. The Pengerang Integrated Petroleum Complex (PIPC) is a huge development that has emerged on the east coast of Johor. Comprising Petronas' largest refinery facility and numerous ancillary and supporting industrial areas, it is pegged to diversify Malaysia's petrochemical industry and reap the benefits of the area's fortunate position on international maritime trade routes. While initial responses to the PIPC development were of concern for Singapore's oil and gas business, the island-nation's long reputation and position in the industry means that the PIPC has some steep learning curves to traverse before coming on par with its southerly neighbour. However, the PIPC is likely to provide a solution to Singapore's limitations in terms of costly services and limited land space. It may also rejuvenate an industry now seen by some SMEs to be somewhat stagnant. While there are myriad global trends that may inhibit the complete success of the PIPC, it seems to be well placed to provide economic spillover benefits for Johor and Malaysia. Even if it does not become a top regional player, it will be able to meet local demands for Euro 5 quality products.

For Indonesia, which is keen to accelerate its infrastructure development, Belt and Road Initiative (BRI) is seen as an opportunity to tap into China's huge financial resources and technological capability. There has however been no concrete BRI project agreed to between China and Indonesia so far. While China considers all projects, including infrastructure projects and economic interactions as part of BRI, Indonesia only considers those infrastructure projects initiated during the Xi Jinping period as BRI projects. Indonesia has offered several broad areas for cooperation under the BRI framework and carefully selected project locations to minimize political risk for the Joko Widodo government. But no agreements have been signed yet as China requires detailed project proposals from Indonesia, which it has apparently not received. What appears to hamper progress are four key issues: the perception of China's economic domination, the ethnic Chinese issue, the Natuna issue, and the mainland Chinese workers issue.

It includes the commercial, security, education and diplomatic, and other domains. However, this presence is not very well appreciated or reported by regional media, whereas China's presence and influence is pervasive. Most Southeast Asian governments are often reluctant to recognize or publicize the US presence or contributions to regional security, stability, and growth. As US-China competition escalates, Southeast Asia will become an epicentre of this competition. Southeast Asian states and ASEAN must elevate their own emphasis and engagement with the US. The US brings many more strengths and benefits than does China and is a far more comprehensive actor in the region. In particular, it would be helpful if ASEAN and its member states would more publicly recognize the contributions and importance of the US.

It is tempting to say that unintended consequences happen because we live in an uncertain and unpredictable world, and that there is not much we can do to prevent their occurrence or prepare for them. In fact, many unintended consequences are neither predetermined nor random. It is true that whether or not unintended consequences happen will be affected by many economic and social factors that Singapore is confronted with, but much will also depend on how we approach these factors and the potential consequences.

This book, based on the proceedings at the Behavioural Sciences Institute Conference 2017, explores various issues about unintended consequences in Singapore. The book is organised into four parts. Part 1 provides an overview of issues involved in thinking about unintended consequences. Part 2 examines unintended consequences in the context of Singapore's goal to become a smart nation and compares the perspectives between public and private sector organisations on dealing with uncertainty. Part 3 analyses the relationships linking unintended consequences to healthcare outcomes and the management of race relations in Singapore. Frequently this dispersion was forced, often with traumatic results. Today, Javanese communities are found as close as Kalimantan and as far away as Suriname and the Netherlands. Meanwhile, migrant workers from Java continue to travel abroad, finding short-term employment in places like Malaysia and the Middle East. This volume traces the different ways in which Javanese migrants and migrant communities are connected in their host society and with Java as a real or imagined authoritative source of norms, values and loyalties. It underlines the importance of diaspora as a process in order to understand the evolving notions of a Javanese homeland across time and space. Even though Java as the point of departure links the different contributions, their focus is more on the process of migration and the experiences of Javanese migrants in the countries of destination. Clearly, the labour element dominates the Indonesian overseas experience. But the volume also elucidates how ethnicity, class, gender, religion and hierarchy have shaped and still inform the dynamics of diasporic communities. Many of the chapters pay particular attention to gender as women now form the majority of international migrants, domestic work being the largest category of transnational work. As a result, important aspects of the migration experience are seen in new ways via the lens of women's experiences.
