Herman Hochstadt, or hrh as he is better known, joined the civil service in 1959, moving to the position of secretary to Lee Kuan Yew's Prime Minister's Office. hrh had an unusual ability to inspire those working for him, and his signature wit and charm are on display here, in the ways he weaves together stories of his career and some of the key moments of Singapore's development.

He begins with his family's history in Singapore, including that of his grandfather, John Hochstadt, who founded the Singapore Casket Company. He then continues through his childhood and an education part of which coincided with the Japanese occupation, before moving on to his working life. Hochstadt has held many positions across the public and private sectors, such as acting director of manpower of the Ministry of Defence when Singapore had to build its armed forces from scratch. He was instrumental in many pivotal moments in modern Singapore's history, including being the logistics coordinator of the delegation to Singapore's 1965 admission to the United Nations. During his later career, he was high commissioner to several Commonwealth African nations.

Full of warmth and humour, the lives and times of hrh traces a life dedicated to public service in Singapore, from its time as a crown colony through its evolution to the Republic of Singapore.

Jacob Gotfried Haafner (1754-1809) was a writer of great talent, and an early dissenting voice from within the colonial enterprise. Haafner was orphaned in the Dutch East Indies, and lived in South Africa, Sri Lanka, India and Mauritius for more than 20 years. On his return to Europe he transformed himself into one of the most popular Dutch writers of the early 19th century, for his travel writing in the Romantic mode. Books like his popular Travels in a Palanquin were translated into the major European languages, and his essays on the havoc wrought by missionaries worldwide stirred up great controversy, particularly in his home country of the Netherlands. He was a fierce critic of English machinations in India: "Had I to write the history of the English and their deeds in Asia", Haafner once said, "it would be the spitting image of hell". But there was a scholarly side to him to complement the pamphleteer and travel writer, working to promote European understanding of Indian literature, myth and religion, including through his translation of the Ramayana into Dutch. With the help of generous excerpts from Haafner's own writings, including material newly translated into English, van der Velde tells an affecting story of a young man who made a world for himself along the Coromandel Coast, in Ceylon and Calcutta, but who returned to Europe to live the last years of his life in Amsterdam, suffering an acute nostalgia for Asia: "No, in Europe and especially in its northern climes, no one enjoys their life..." In 1955, he had three portraits exhibited at the Institute of British Photographers Exhibition of Professional Photography at the R.B.A. Gallery, London. In 1956 he was awarded the Associateship of the Institute of British Photographers (A.I.B.P) for portrait photography making him just one of two Malayans to receive the honour. In 1957, he became an Associate of the Royal Photographic Society of Great Britain (A.R.P.S.). The following year, he was made a Fellow of the Royal Society of Arts (F.R.S.A).

The Malaysian National Higher Education Fund Corporation (PTPTN) was set up in 1997. Since then, it has accumulated a massive debt amounting to RM40 billion in principal plus RM13 billion in interest. All these are guaranteed by the Malaysian government.

It is now the biggest provider of student loans in the country and continues to play a very important role in catalysing socioeconomic mobility, especially among the ethnic Malays which is the majority community in the country.

However, the business model employed by PTPTN is irrational and unsustainable. It borrows from the financial market at, on average, 4 to 5 per cent, and lends to students at 1 per cent. No serious effort has been made to revamp this model, and all public discussions around it have been driven by political populism.

The biggest challenge is the low repayment rate. This problem has been ignored because Malaysian politicians of all colours have wanted to maintain popularity. Collecting debt is certainly not popular.

PTPTN, under a new leadership since mid-2018, gathered and developed ideas on how to reform their organization. These ideas have been presented to various levels of government, including to the Cabinet in early 2020.

PTPTN must be reformed to avoid its debt from inflating further. Whether the Malaysian government has the much-needed political will to push through the reforms is a question yet to be answered.

The year 2019 marks Singapore's Bicentennial milestone since the arrival of Sir Stamford Raffles in Singapore in 1819. It was in anticipation of the arrival of the Bicentennial that this book, Beyond Bicentennial: Perspectives on Malays, was initiated. The emergence of the Islamic State (IS) movement in Indonesia in 2014 re-energized violent extremism in Indonesia. As a result of effective counterterrorism policing, however, IS networks have been decimated and the structure of jihadism

in Indonesia has shifted from organizations to autonomous networks and cells, increasingly organized via the Internet. Although support for violent extremism in Indonesia remains marginal, cells of IS followers maintain a low-level capacity to conduct lethal attacks against civilian and government targets.

Most IS operations in Indonesia are sporadic and low-level attacks against the Indonesian police. Religious minorities have also been high-profile targets, as in the Surabaya church suicide bombings of 13 May 2018. There are some indications, however, of militants' renewed interest in attacking foreign targets, such as tourists on the resort island of Bali. IS returnees from the Middle East have begun to play a role in recent attacks. The presence of this population in Indonesia raises the risk of militant capabilities being enhanced above their current relatively low level. Most returnees are women and children, and the increasing involvement of this cohort in IS attacks promises to complicate counterterrorism operations. The rise of pro-IS charities in Indonesia, poised to service returnees and reintegrate them into Indonesia's jihadist community, further exacerbates this problem. The overall threat of terrorism to the Indonesian state and to the stability of the Joko Widodo administration remains low. Surprise attacks by unknown cells, however, have the potential to shock the Indonesian political system, provoking government repression of Islamists and exacerbating political

Southeast Asia's Internet users are far more diverse than usually reported. They range from the urban youth with laptops and high-speed Wi-Fi, to the older generation semi-rural and rural users with affordable mobile phones for Facebook and WhatsApp.

Southeast Asians generally trust social media platforms more than in Western societies. This trust in social media reflects a lack of trust in local mainstream media and official sources of information.

What campaign information (and disinformation) is being spread and which ones are most successful are essential for understanding how voters in Southeast Asia use and trust social media. Social media platforms and Southeast Asia's "app industry" need clearer and enforced regulation on their use of data and the extent to which they can sell data to advertisers. These advertisers include, but are not limited to, politicians and political parties.

Since the future of social media usage will likely lie in closed groups, the role of big data analyses that have dominated research on social media over the past ten years, is likely to regress. Instead, ethnographic scholars who can access these groups and engage with their particular interests and identities

are more likely to be useful in understanding the digital sphere in the future.
