Tay Kheng Soon is one of Singapore's most important public intellectuals and thinkers. A pioneering architect of Singapore's post-independence era, Tay belongs to a select group of individuals who literally put their footprints on Singapore's development - physically and intellectually. He was Chairman of the Singapore Planning and Urban Research Group (SPUR) in the 1970s and later president of the Singapore Institute of Architects, receiving its Gold Medal in 2010. His design research extends beyond architectural scale to urban planning and finally to the global scale. Tay is a Fellow of the World Academy of Art and Science and a member of the World Ekistics Society, and founding Chairman of the Substation, the experimental centre of the Arts community. Beyond thinking about suitable built forms for the tropics, and the aesthestics of design, Tay takes a holistic approach to planning the built environment and wrote prolifically about these ideas. This collection brings together, for the first time, Tay's writings on these and various other topics that occupied him in a lifetime of thinking, teaching, building and expounding. His range is vast, traversing subjects as diverse as outdoor education, urban morphology, town planning, national identity, regionalism, ageing in place and the political economy of design.

These relate to the planning and design of outdoor spaces and enabling opportunities for active, healthy ageing. Importantly, our research prioritises the need to engage with older people when creating neighbourhood environments that contribute to healthy ageing in place.

The book and its supplementary toolkits touches on 3 main stages of age-friendly neighbourhood project — planning (environmental audit), implementation (planning and design guidelines) and evaluation of progress made (postimplementation review). We hope that these materials will contribute to the ongoing discourse of how to (re)envision urban neighbourhoods to enhance health and quality of life as people age. Needless to say, they do not supersede but support existing guidelines or regulations to improve everyday neighbourhood environment for healthy ageing in place. Co-creation with older people is a central tenet of our research on ageing urbanism at the Lee Kuan Yew Centre for Innovative Cities. The Lee Li Ming Programme in Ageing Urbanism conducts applied research on built environment and health of ageing population, arguing for a more integrated environmental, social and spatial approach to identify the connection between the built environment, health and quality of life that can inform the design for age-friendly neighbourhoods and communities.

Chia Ann Siang was once one of Singapore's wealthiest landowners and merchants. His name lives on today in Ann Siang Hill in Chinatown, but little else is known about him, particularly his private life. This illuminating new book paints the most detailed portrait to date of his life and times in colonial Singapore and traces the changing fortunes of the Chia clan through the years. Born in Malacca in 1834, Chia joined Boustead and Co., an English trading company in Singapore, as a storekeeper at the age of 16. In just six years, he was made Chief Storekeeper, and was able to buy himself a house at 58 Telok Ayer Street (and another one on Amoy Street for good measure). An astute property in vestor, Chia continued to acquire much real estate in the course of his life; by 1919, he owned more than 70 houses in Chinatown. In 1873, he purchased a large piece of land from John Gemmill, which soon became known officially as Ann Siang Hill. Chia Ann Siang died in 1892, leaving a fortune that supported two generations and educated a third. This book looks at the disparate fortunes of his descendants, including a son he disinherited for marrying against his wishes, and a daughter whose marriage brought two wealthy families together. Far more than a biography, this book tells the fascinating story of more than seven generations of Straits Chinese, from Chia's grandfather's emigration from Fujian to Malacca in 1774, right up to the present day. http://www.marymartin.com/web?pid=778535

Soul of Ink: Lim Tze Peng at 100 pays tribute to the remarkable achievement of artistic renaissance at 100. It traces the lean beginnings of Lim Tze Peng's early years, relives the times of controversy over the artist's innovations in Chinese calligraphy, and celebrates his breakthroughs. Throughout the book, attention is paid to Lim Tze Peng the man, the foundation of everything that is admirable about Lim Tze Peng the artist. It looks at the man behind the art, and how art has given life to him and his family.

Farmer, teacher, principal, and artist, Lim Tze Peng counts Lee Man Fong, Cheong Soo Pieng, and Liu Kang as his mentors. These men, like the others from the pioneering generation of Nanyang artists, are no longer around. Lim Tze Peng remains standing, a witness to and player in Singapore's art history since the 1940s.

His life started late; everything got going only after the ripe old age of 80. A Cultural Medallion winner at 82 and a Meritorious Service recipient at 95, Lim Tze Peng is used to the twists and turns of life and has been trained by experience to endure the vagaries of fate. You could describe his art as the art of perseverance. The works he produces these days need to be seen to be believed. Bigger, bolder, and boasting far more colour than ever before, his art is as invigorating as that of a young man, whilst embodying the soul of a sage.

At the heart of this book is the word "soul". What pushes a man at the age of 100 to continue breaking new ground in his life's work? How has he been able to surprise not just the art community but himself?

Singapore's rapid ascent from Third World to First since its independence in 1965 has won it acclaim as an "economic miracle". Economic success has been accompanied by impressive achievements in social development, as reflected in international rankings of human capital and human development.

The city state's achievements are founded on a socio-economic system characterised by low tax rates, flexible labour markets, and individual "self-reliance", with state support centred on social investment in education and public housing. Entering the 21st century, however, slowing economic growth, an ageing population, global competition, and widening income dispersion have put the Singapore System under strain. This has prompted a significant refresh of social and economic policies over the past 15-20 years.

Everyone remembers his or her school days. They make up our most powerful memories. The school experience is like an enjoyable and exhilarating boot camp that helps prepare us for adulthood. School is where we discover our talents and develop our interests. It is where friendships are formed and leaders nurtured. It is perhaps where we even met our first love.

As Singapore crossed into the 21st century, the education system had to evolve, moving in tandem with the changing needs of society, shifting attitudes, new mindsets and focus. With technological advancements, school infrastructure has been enhanced and redeveloped. Although many of our preindependence schools are no more, the lived experiences of pupils who call them alma mater are by no means easily erased or diminished. Two of these schools were named in honour of Southeast Asia's historic personalities: Sang Nila Utama (the founder of Singapura) and Tun Seri Lanang (Grand Vizier and literary figure). These premier secondary schools paved the way for pupils in the Malay stream to pursue a fulfilling secondary education, something which they would not otherwise have been able to do for want of resources. In fact, these schools were so outstanding that they attracted top students from Malaysia, Indonesia and Brunei to study in Singapore.

Teochew-speaking gambier and pepper farmers were early settlers of Singapore at the turn of the 19th century. Wak Hai

Cheng Bio, now surrounded by the skyscrapers of Singapore's central business district, traces its history back to the earliest days of the colony. Its two deities - the Emperor of Heaven and Mazu, the Goddess of the Seas, tutelary deities of the Teochew people and travellers by sea respectively, long accompanied the sojourns of Teochew-speakers in the region. No written sources or inscriptions commemorate the founding of the temple, but the author's research in the history of land tenure of Singapore and old maps and title deeds provide new evidence for the temple's foundation. Just as eloquent as these forms of textual evidence, and the many poetic and commemorative inscriptions that enliven the temple and charge its spaces with meaning, is the testimony of the building itself, its siting, materials, its ornamentation and artworks. The author led the UNESCO award-winning effort to restore the temple from 2010 to 2014, and so is uniquely placed to understand what its architecture can tell us of the legacies and histories of the communities that formed and were formed by the temple. The book is exemplary in the way it uses material culture and architectural history as historical sources, and so will be of interest to heritage studies, history and those seeking to understand the experience of Chinese communities in Southeast Asia.

The year 2021 marks the thirtieth anniversary of the signing of the Cambodian Peace Agreements which ended the Cambodian conflict and the Cold War in Southeast Asia.

Communism was a perennial concern in Singapore and Malaya (later Malaysia) from 1948 into the 1980s -- a concern which younger generations may not appreciate. The threat came largely from the Communist Party of Malaya (CPM) supported by China, and from Vietnam.

The CPM waged a guerrilla war in Malaya. They were defeated by 1960 but tried to revive the insurgency in the 1970s. In Singapore they attempted to attain political power through a united front with the People's Action Party during the 1950s. The victory of the communists in the Vietnam War in 1975 alarmed non-communist Southeast Asia. The concern was aggravated by Vietnam's invasion of Cambodia in 1978. ASEAN states strongly opposed Vietnam's action on the grounds that the invasion and occupation of a sovereign country violated a fundamental principle of international law. Successive UN General Assembly resolutions supported the ASEAN position with significant majorities.

Thailand was pivotal to the security of the rest of non-communist Southeast Asia. Had it succumbed to Vietnam's pressures and reached an accommodation with Hanoi, the security of the rest of Southeast Asia would have been endangered. Thailand stood firm. Had it not done so, the people of Southeast Asia would be living in a different world today.

Lion City Narratives: Singapore Through Western Eyes fulfils four aims. First, it is a study of subjective Western impressions of Singapore's 145 years (1819–1963) of colonial history. The study is not meant to be an in-depth historical analysis of

Singapore, but rather to give the reader an impressionistic account of how Western residents viewed Singapore over the decades. Second, this study could be seen as a short biography of Singapore's evolution as a city. The chapters on the imageability of Singapore and its urban morphology provide a holistic perspective of Singapore's urban dynamics. Third, this book provides a cultural insight into Singapore's population, both White residents and transient visitors, as well as the locals or Asians. Fourth, it opens a window into Singapore's development at a time when the West was at its cultural zenith and when Great Britain was the principal superpower of the 19th century. Hence Singapore carried twin colonial legacies — it was the archetype trading emporium between East and West, and it became, for the British, the major point d'appui for defence. Finally, the Singapore colonial narrative is set in a broader academic discourse that allows the reader to see a wider picture of Singapore's colonial development. The book does not attempt to make a definitive statement about the Western involvement in Singapore; it deals more with an association of many subjective Western perspectives that add colour to the liveability of the tropics, perceptions of the exotic Orient, and the myriad views of ethnic groups. Without the Western writings, paintings, and maps, academia would have minimal records of Singapore's development. As a new colony in the early 19th century however, Singapore's growth has been extremely well documented. This book will appeal to Singaporeans interested in understanding Singapore's colonial past, Westerners interested in the Western cultural persona in the development of Singapore, researchers dealing with the urban development of less-developed countries and colonial development in the tropical world, and lastly, academics who are interested in Singapore and the region's political and economic development as a case study.

Pioneer Merchants of Singapore tells the stories of some of Singapore's earliest merchants, including Alexander Laurie Johnston, Edward Boustead, Alexander Guthrie, and eleven others, including Tan Che Sang, Dr Jose d'Almeida, and D S Napier. Much has been written about Sir Stamford Raffles and Lt. Col. Farquhar, but almost nothing has been published about these merchants of all races operating in Singapore during the first few years following its acquisition by the East India Company in 1819. It includes never-before-published information drawn from letters dating back to 1818. These, including letters from Johnston's first employee and business partner Andrew Hay and a previously unrecorded letter from Raffles himself, shed light on much which otherwise would have been lost to us.

This book aims to fill a gap in our knowledge of the early days of Singapore and the challenges faced by its early residents. This volume presents critical editions of two previously unpublished missionary accounts of Ayutthaya and the East Indies scene after the "National" Revolution of 1688 in Thailand. The texts presented are *Relation de Voyage aux* Indes, 1690-99, by Guy Tachard, a French Jesuit; and Relatione Distinta delli Regni di Siam, China, Tunchino, e Cocincina (ca. 1707), by Nicola Cima, an Italian Augustinian. These interesting, substantial texts tell us a lot both about the Europeans who were writing them, and about Southeast Asia in a period when information was in much shorter supply than prior to 1688, and when kingdoms across Southeast Asia tended to retract from outward engagement and to become what historians have christened "hermit kingdoms." They are coloured by delusional thinking: in Tachard's case of an active French colonial presence in that part of the world irrespective of the lessons of 1688-89, or in Cima's case, of a revived Venetian maritime trade to the East Indies in an unlikely partnership with the Danish East Indies Company. Including a substantial introduction to contextualize the accounts, this book makes available in English some primary source material addressing important and overlooked aspects of the European missionary mentality.

Thus, modernization and industrialization that were the chosen paths of the postcolonial Vietnamese government, become the major targets of contemporary Vietnamese ecofiction. All these stories, extremely contemporary, emphasise a counternarrative that challenges socialist goals of development and modernisation. They articulate and affirm a more holistic vision, where man is no longer a predator but a participant of nature. The failure of two expected transitions of leadership from Dr Mahathir Mohamad to Anwar Ibrahim (in 1998 and 2020) are traceable beyond their personal entanglements to the social divides and political currents of their time.

The unrealized transitions are symptomatic of UMNO's dynamic of "dysfunctional succession". Under Mahathir, the party split. Under Najib, it was defeated. The condition persists as the current Prime Minister, Muhyiddin Yassin, has not even appointed a deputy prime minister after being in power for fifteen months.

The unrealized transitions were a setback for a "reform agenda", which Anwar Ibrahim articulated, but which emerged from dissident movements for diverse reforms. These movements helped the multiethnic, socially inclusive, opposition to win the 14th General Election. They are only seemingly dormant because of the pandemic.

The Pakatan Harapan regime had the best chance to supply a fresh vision, deeper social understanding, and commitment to reform. The present Perikatan Nasional regime's fixation on "Malayness" overlooks twenty years of intense intra-Malay conflicts that began with the failure of the first transition. As the "7th Prime Minister", Mahathir had a rare chance to redeem himself from major errors of his first twenty-two-year tenure. He squandered his chance by not honouring the Pakatan Harapan transition plan.

Anwar Ibrahim's opponents mock him for being obsessed with wanting to be prime minister. Yet they obsessively fear his becoming prime minister. Anwar may be twice loser in political succession but "the spectre of Anwar" still haunts Malaysian political consciousness.

Lately, the group has been cast under the spotlight over a range of issues, from underperformance in the national examination, their ability to integrate into the broader society, exposure to radical and conservative ideas such as Salafism from the Middle East, and unemployment. Reaching for the Crescent examines a growing segment within the group, namely Islamic studies graduates, who obtained their degrees from universities in the Middle East and neighbouring Malaysia and Indonesia. It identifies factors that condition the proliferation of Islamic studies graduates in Singapore, examine the dominant religious institutions they attend, the nature of Islamic education they received, and their challenges. It tackles the impact of their religious education on the spiritual life and well-being of the community. The concept of the Islamization of knowledge was introduced by Syed Muhammad Naquib Al-Attas in the late 1970s. It aimed to detach knowledge from Western culture and civilization in order to replace it with Islamic concepts, frameworks and values.

The Islamization of knowledge was to occur in the fields of education and culture, manifesting in changes to the syllabus in institutions of higher learning and niche areas of interest in selected research institutes. In the field of culture, however, it resulted in an unintended consequence of Malay literature being heavily characterized by Islamic elements.

Over the years, proponents of the Islamization of knowledge in Malaysia have moved beyond the fields of education and culture. They have entered the mainstream and become part of the state machinery, thus possibly impacting national policies. The concept has also evolved and arguably led to the

strengthening of Islamic conservatism among Malaysian intellectual and cultural elites.

When more than 93 per cent of the citizens of one country profess a single religion, as Thais do Buddhism, and when that religion is deeply integrated into national institutions and ideologies, it becomes tempting to think of the religion as a textual, institutional, cultural and conceptual whole. But at the same time it is obvious that expressions of Buddhism in Thailand reflect anything but a single order: they are often gaudy, cacophonous, variegated, and jumbled: almost technicolor. Diversity and apparent contradiction are everywhere. A more open engagement with Buddhism in Thailand will require a willingness to be distracted, to step away from received hierarchies and follow the intriguing detail in the ornate design, the odd textual reference, to prefer "thin description" over a search for meaning. Collected together for the first time, and set in place by a compelling introduction that argues for a strongly materialist approach, these essays cover subjects ranging from ornamental art to marriage and emotion, the role of Hinduism, neglected gender and ethnic diversity, Buddhist inflections in
