[In this lively and visually engaging work on Western conceptions of Tibet, anthropologist Martin Brauen paints a vivid portrait of misinterpretation, trivialization and political and commercial exploitation of a rich and ancient culture. Starting with romantic notions of 17th century adventurers in search of a Himalayan Utopia, Brauen discusses misconceptions both amusing and disturbing, such as the distortions of 20th century neonazis. The author also details the cynical exploitation

of Tibetan Buddhism a fundamental objective of which is the elimination of human greed to further Western commercial aims.

Nor does Brauen absolve Tibetans themselves in the use more benign, even flattering, of these distorted images, as they strive to draw the world's attention to their own politically and socially tenuous situation. Here the author lists the traditionally tolerant nature of Buddhist beliefs, the tendency of Tibetans of submit without question to authority figures, factors. The book concludes with a caution on the dangers that these misconceptions pose to a mature presentation of the value that Tibetan culture holds for the world.]

[Excavations at the Ban Wang Hai archaeological site at Muang direct, Lamphun province, northern Thailand, revealed numerous graves of adults, infants and newborns, dating back more than 2000 years. Many graves were accompanied by items such as iron tools, bronze ornaments, glass beads, and clay pots, providing fascinating new insights into a little-known period of prehistory in this part Southeast Asia.

The rarity of such finds within this region, and the quantity of their condition, mark this site as one of great archaeological interest.

The Ban Wang Hai site was studied between 1996 and 1998 as the second part of a cooperative undertaking between the Fine Arts Department of Thailand and the French government represented by the Guimet Museum in Paris, the National Center of Scientific Research, and the Ministry of Foreign Affairs. The first part of the Thai-French Prehistoric Research Project, from 1985-1995, studied the Paleolithic culture at the Ob Luang archaeological site at Hot district, Chiang Mai province.

The project was undertaken by a team led by French archaeological Jean-Pautreau and Patricia Mornais, in association with Tasana Doy-Asa of the Division of Archaeology, Fine Arts Departments, Thailand.]

[The papers in this volume are the results of an East Asian Development Network (EADN) regional research project on Indicators and Analyses of Vulnerabilities to Economic Crises coordinated by the Thailand Development Research Institute (TDRI). The aim of the project is to learn from the recent economic crises that severely affected most economies in the region, and develop indicators that could be used to forewarn of future crises.

Studies were carried out for six countries; China, Indonesia, Philippines, South Korea, Thailand and Vietnam, together with a synthesis report. Four of the six countries were strongly affected by the 1997 crises; Indonesia, the Philippines (mainly through contagion), South Korea and Thailand. For these countries, similar methodologies (signaling and probability approaches) were applied, and the studies also used the results to make assessments of the risks of crises under recent conditions. China and Vietnam did not go through a similar crises to the other countries, so using similar methodologies to the other countries would not make much sense. The country authors therefore focused on specific issues that may create future vulnerabilities and risks to the economy. China focused on the problem of non-performing loans in the banking system, which is very high due to problem loans state-owned enterprises. Vietnam focused on the problem of capital account sustainability. The studies for these two countries also attempted to assess of the future risks for their economies and also identified necessary policy responses.]

[Since the financial crisis erupted in Thailand in 1997, the Thai authorities have implemented a number of drastic financial-sector restructuring measures to restore financial stability and address prevailing structural weaknesses. The restructuring measures have been based on both market-driven and state -led mandatory approaches and could be categorized into two main groups :

(1) those intended to address financial institutions insolvency and capital adequacy , and (2) those intended to address non-performing loans and distressed assets. Owing mainly to the severe magnitude of the crisis, total public costs of Thailand's financial-sector are estimated to be in range of 30-40 percent of GDP, raising serious concerns over the country's long-term public debt sustainability.

While the Thai financial-sector restructuring process is not yet complete, this study highlights relevant policy issues and tradeoffs as well documents the rationale and the main features of key restructuring measures that have been implemented by three governments during the past five to six years. It also reviews their effectiveness, incentive structure, operating constraints, associated public coats, and subsequent impact on the Thai financial system going forward. It is hoped that the menu of policy and operational issues discussed in this study will assist the authorities of other crisis-affected countries in designing their financial-sector restructuring measures in the cost-effective manner.]

[With the Austrian Frigate Novara in the Nicobar Islands (1858) is excerpted from the popular version of a report by Dr Karl von Scherzer, a member of an extremely well-prepared, round-the-world expedition carried out between 1857 and 1859, and sponsored by the Austrian imperial government. The Nicobar Islands, now Indian territory, lay on one of the busiest shipping routes in the world, and yet not much was systematically recorded about the local population until well into the 20th century. These people, numbering not more than 6,000 in all, lived from coconut exports, and to a lesser extent from Pandanus trees, edibleswallows' nests and sea cucumbers. The staff of the Austrian expedition included geographers, geologists, and natural scientists, all of whom contributed to von Scherzer's report. Von Scherzer himself was one of only a very limited number of Europeans to come into contact with the local people, except for ships' captains, whose names the locals habitually adopted. Captain John Bull, a local chieftain who accompanied various Austrians around the southern islands of the archipelago, and other colorful indigenous people were contributing unwittingly to their own destruction because the expedition was looking for areas where Austrian colonial settlements could be set up. The Austrian naval officers on board the Novara also produced a score of first observations and an improved navigational chart of the area, which is included here

as a folded map. The book includes a short history of the foreign relations of the Nicobar Islands not found elsewhere.]

Each stamp is illustrated, with pertinent information for the stamp collector including the date of issue, the printer, the type of printing, and the perforation size. The book is careful to point out variants and successive printings, noting the features that distinguish each one, with detail enlargements to aid identification, when necessary. This handy volume also includes the complicated surcharges of King Chulalongkorn's reign, as well as a final table listing the print-run of every stamp featured.]
