Beginning in the 1980s, the ethnic landscape of Taiwan began to change. Democratization drastically altered the long-existing situation of "minority rule" by political elites exiled from mainland China to a situation of "majority rule", whereby local Taiwanese were finally able to enjoy legitimate political rights and civil liberties. The definition of ethnicity was also reconceptualized. The three sociologically and anthropologically defined "ethnic minorities" were then recreated, i.e., the indigenous Austronesian peoples, the Hakka, and the new immigrants from Southeast Asia.

The period also saw the rise of ethnic movements. On the one hand, the indigenous peoples and the Hakka organized their own respective ethnic movements to demand that the government protect their ethnic rights and upgrade their position in mainstream society. On the other, Taiwan's local civil society organizations, such as concerned non-profit organizations (NPOs) and non-governmental organizations (NGOs) assisted and protected two other new minority groups, namely, marriage and labour immigrants from Southeast Asia. Accordingly, different forms of political pressure and various policy impacts have been observed over the years: while the self-mobilized ethnic advocacy movements of the indigenous peoples and the Hakka were created to force the government to make policy changes, the service NPOs/NGOs were established to help marriage and labour immigrants mostly operate under existing government policies and regulations.

The Taiwan experience, as judged by the ethnic movements of the indigenous peoples and the Hakka, has proven that only when minority groups mobilize themselves are they able to eventually push the state into making necessary concessions and policy changes.

After the collapse of the communist system in Yugoslavia the nationalistic aspirations of Serbs and Albanians were apparently strengthened. In line with this their embracing of a distinct ethnic also increased. Consequently, it is worth considering whether Kosovar Turks' appeals to identity appeals have changed or not? Kosovar Turks were also exposed to pressures during the 1990s and this could have affected their nationalistic appeals. Thus, Turkish identity aspirations might have strengthened between 1992 and 2010. In order to test it, I will analyse the number of the students who participated in Turkish language education in Kosovo throughout the period mentioned above. One assumption here is that the number of the students who follow Turkish language education in schools is proof of a commitment to Turkish identity but I see no strong reason to doubt this assumption. Changes in the number of the students then should reflect the level of commitment to Turkish identity.

Although the official propaganda surrounding the drug detainees in China is that of helping, educating, and saving them from their drug habits and the drug dealers who lure them into drug abuse, it is clear, according to Vincent Shing Cheng, that those who have gone through the rehabilitation system lost their trust in the Communist Party's promise of help and consider it a failure. Based on first-hand information and established ideas in prison research, Hypocrisy gives an ethnographic account of reality and experiences of drug detainees in China and provides a glimpse into a population that is very hard to reach and study. Cheng argues that there is a discrepancy between the propaganda of 'helping' and 'saving' drug users in detention or rehabilitation centres and the reality of 'humiliating' them and making them prime targets of control. Such a discrepancy is possibly threatening rather than enhancing the party-state's legitimacy. He concludes the book by demonstrating how the gulf between rhetoric and reality can illuminate many other systems, even in much less extreme societies than China.

Young scientists are a powerful resource for change and sustainable development, as they drive innovation and knowledge creation. However, comparable findings on young scientists in various countries, especially in Africa and developing regions, are generally sparse. Therefore, empirical knowledge on the state of early-career scientists is critical in order to address current challenges faced by those scientists in Africa.

This book reports on the main findings of a three-and-a-half-year international project in order to assist its readers in better understanding the African research system in general, and more specifically its young scientists. The first part of the book provides background on the state of science in Africa, and bibliometric findings concerning Africa's scientific production and networks, for the period 2005 to 2015. The second part of the book combines the findings of a large-scale, quantitative survey and more than 200 qualitative interviews to provide a detailed profile of young scientists and the barriers they face in terms of five aspects of their careers: research output; funding; mobility; collaboration; and mentoring. In each case, field and gender differences are also taken into account. 'My hope and expectation that the Havelock North Drinking Water Inquiry would waken us from our national slumber has not been realised.'

In August 2016, 40 per cent of the residents of Havelock North were struck down by a serious bacterial infection. New Zealand, Skegg explains, must invest more in public health and find the political will needed to oppose the forces that damage health. Personal health care is important, but we neglect public health at our peril.

Are women past caring? Care is essential to social relationships and individual well-being. It is woven into New Zealand's key social institutions, such as the family, and is also embedded in societal expectations around state provision of health and welfare. Care is so vital, in fact, that it is often taken for granted and goes unnoticed and unrewarded.

Historical and philosophical enquiry have largely ignored the issue of care, yet it raises profound questions about gender, justice and morality. The essays in this volume raise those questions directly – at the level of abstraction where prominent New Zealand women philosophers grappled with the political implications, and on the ground at the level of family relationships.

Understanding the history of care requires attention to personal narratives, such as a Māori grandmother's story, a Rarotongan leader's concept of duty to her people, or the sense of service that drove a long-term social worker. The foundations of Past Caring? lie with Making Women Visible, a national conference on women's history held at the University of Otago in February 2016. This important volume opens up a set of perspectives and experiences of caring to begin a conversation about urgent questions facing New Zealand society. How do we recognise, reward and do justice to those acts that hold our society together?
