The study examines two ongoing conflicts: with the Myanmar government who claim that in the absence of formal titles Karen lands are "unoccupied", and hence available for commercial development; and with the government and international environmental agencies, who believe against the evidence that preservation of Tanintharyi's biodiversity has to be taken out of experienced Karen hands and turned into a project run by international consultants lacking familiarity with the area and its community. Similar conflicts are bound to occur elsewhere in Myanmar and this study will provide an invaluable source of information and analysis in such cases.
