At the 1974 World Food Conference, the term "food security" was defined with an emphasis on supply; food security is defined as the "availability at all times of adequate, nourishing, diverse, balanced and moderate world food supplies of basic foodstuffs to sustain a steady expansion of food consumption and to offset fluctuations in production and prices". Later definitions added demand and access issues to the definition. The first World Food Summit, held in 1996, stated that food security "exists when all people, at all times, have physical and economic access to sufficient, safe and nutritious food to meet their dietary needs and food preferences for an active and healthy life."

However, it is far from inconceivable that this will remain. Given we have already seen officials at the highest level of the administration of our Special Administrative Region being prosecuted for corruption-related charges, what is contemplated is that it might be in the future that corruption of such officials might involve an impact to the endangerment of the national security of the People's Republic of China.

There is also commentary from the New South Wales Court of Criminal Appeal, which further defines the parameters and elaborates the significance of proving the purpose of corruption when establishing the offence. Further commentary on the developments of justices of the Court of First Instance and District Court are also discussed in this edition.
